# Amendment Discussion for Parking Ordinance Chapter 24 Amendment

# 16-922 Farmland Protection Advisory Board Update

#### Agenda Text:

The Board is requested to receive an update from the Farmland Protection Advisory Board on its recent accomplishments. Durham County agriculture has undergone a transformation over the past decade with the emergence of a diverse small farm sector focused on local marketing opportunities. New opportunities are emerging for small farms to sell food and services in the local marketplace, yet agricultural operations require a stable land base to innovate and make new investments. Durham County's farms provide nourishing food for our community and the Farmland Board has assisted with getting these products to the county citizens. Additionally, the farmland in the County's watersheds helps to preserve clean water for residents. Farmers also pay far more in taxes than they consume in taxpayer-funded services, helping to subsidize such services in developed parts of the County. This presentation will touch briefly on the cost of community services.

In 2009, the BOCC approved an Agricultural Development and Farmland Preservation Plan. The overall goal of this plan was to create a profitable and sustainable agricultural sector in Durham County that can assure a healthy farm landscape and access to fresh, local foods for the next generation. The development of this plan was tailored for Durham County and contains 32 goals. The Farmland Board will present some of its projects completed while discussing some of its future needs to meet other pressing goals.

Alignment With Strategic Plan: This request is aligns with Goal 2 Health and Well-being for All by supporting access to fresh and healthy food for residents, and with Goal 4 Environmental Stewardship by protecting open space while preserving rural character.
