# Approval of the Automatic Aid Agreement with Northern Wake Fire Department for Fire/Rescue Services

#### Agenda Text:

The Board is requested to approve the new automatic aid agreement with Northern Wake Fire Department to provide and receive Fire-Rescue services. The agreement has been reviewed and approved by the County Attorney's Office.

The Stoney Hill Rural Fire Department and Bay Leaf Volunteer Fire Department consolidated on July 1, 2017 and became the Northern Wake Fire Department. As such, a new agreement for automatic aid is desired and necessary for both Durham County Fire Rescue and for Northern Wake Fire Department to maintain and/or improve their Insurance Services Office (ISO) level. The ISO level is what determines business and homeowner insurance rates. The higher the ISO level, the higher the insurance premium.

NC General Statute § 58-83-1 states that "a county, municipal corporation, fire protection district, sanitary district or incorporated fire department shall have full authority to send, or to decline to send, firefighters and apparatus beyond

the territorial limits which it normally serves."

There is no exchange of funds relating to this agreement and this type of agreement is common practice between neighboring fire departments.

Alignment with Strategic Plan: This request aligns with the County's Strategic Goal 3: Safe Community and Goal 5: Accountable, Efficient, and Visionary Government.

### 17-0389 Renewal of Service Contract with TriTech Software Systems

#### Agenda Text:

The Board is requested to renew the service Contract Amendment with TriTech Software Systems ("TriTech") for the provision of software support and maintenance to the Durham County Sheriff's Office in the amount of \$234,521, an increase of 8.2% of over the previous year. The increase is a result of adding a full year of support for two systems, which was previously a partial year, and adding a new module. The proposed service contract renewal is attached and has been reviewed and approved by the County Attorney's Office.

TriTech has been the Sheriff's Office software provider for records management, computer-aided dispatch, and numerous other systems for more than a decade. The services provided under the proposed Service Contract are a continuation of the services currently provided and include software support and maintenance on 24/7 basis for RMS, JAIL, FBR, CAD, INFORM, GeoComm GeoLynx 9-1-1, RMS Evidence Bar Code, MorphoTrak LiveScan interface, NCAWARE to RMS Warrant interface, Renovo interface, and ERMA interface.

Contract to Purchase Solid Waste Vehicle and Budget Ordinance Amendment No. 18BCC000004 Transferring \$156,450 from Vehicle and Equipment Fund Center to the Solid Waste Fund Center for the Purchase

Agenda Text:

The Board is requested to approve a contract to purchase a 2018 Mack Roll Off Truck and Budget Ordinance Amendment No. 18BCC000004 transferring of \$156,450 from the Vehicle and Equipment Fund Center to the Solid Waste Fund Center for the purchase.

The purchase of the roll off truck is being completed through competitive pricing listed on the State of North Carolina's State Term Contracts, specifically Term Contract #0707; Contract Title 50,000 GVWR, Cab & Chassis/Dump Trucks for the period of 01/01/2014 to 12/31/17. The roll off truck will allow the Solid Waste Division with the General Services Department to haul roll off containers and solid waste compactors from the Redwood and Parkwood Convenience Sites as well as the Health and Human Services Complex, Detention Facility, Courthouse and Warehouse.

The truck was approved for purchase as part of Durham County's FY 2017-18 Budget. The transfer of funds will allow the Solid Waste Fund Center to continue the practice of budgeting full expenditure costs related to running the program and setting the County resident collected sticker fee appropriately to support the full cost of the program. As a part of the budget process all vehicles and equipment are removed from their originating fund center to the vehicle and equipment fund center to best analyze those expenses.

# 17-0393 Design Services for Aeration System Enhancements for the Triangle Wastewater Treatment Plant

#### Agenda Text:

The Board is requested to authorize the County Manager to amend the existing design consultant contract with Black & Veatch International Company (FR# 17-832) for Aeration System Enhancements for the Triangle Wastewater Treatment Plant in the amount of \$175,000, bringing the total contract amount to \$213,000.

#### **Background:**

Black & Veatch International Company (B&V) will provide engineering services for the upgrade of the Triangle Wastewater Treatment Plant (TWWTP) Aeration System. The upgrade includes the installation of a diffused aeration system in oxidation ditch number two consisting of two 125 horsepower blowers with variable frequency drives and two membrane disc diffuser grids. The Black and Veatch TWWTP Aeration System Improvement Technical Memorandum completed May 2017 will serve as the outline improvements (Attachment A). Services provided by Black and Veatch International Company include preparation of the plans and specifications, approvals/permitting, construction administration, construction inspection, record drawing preparation.

Engineering design costs for the TWWTP Aeration System Enhancements are estimated not to exceed \$175,000. The construction project will be funded from the Enterprise Fund.

In review of the MWBE compliance for RFQ 17-012 TWWTP Efficiency and Resiliency Improvements, Black & Veatch International Company will be utilizing Milhouse Engineering verified as MWBE certified African-American firm and is expected to achieve up to 10% MWBE participation used on this project. The MWBE Compliance Review form is provided as Attachment B.

Alignment with Strategic Plan: This action is in accordance with Durham County Strategic Plan Goal 4: "Environmental Stewardship and Community Prosperity," as this project will ensure a clean environment by restoring oxidation ditch number two to its original treatment capacity. Additionally, the transition from mechanical surface aeration of oxidation ditch number two to

diffused aeration should result in reduced energy usage at the TWWTP.

# Settlement of 2016 Property Taxes and the Charge of 2017 Property Taxes to the Tax Collector

#### Agenda Text:

As required by G.S. 105-373, the Tax Administrator is herewith submitting the settlement report of 2016 property taxes.

Additionally, the General Statutes bar use of any remedies for collection enforcement that is not instituted within 10 years of said taxes becoming due.

charges the Tax Collector with the 2017 Property Tax Receipts.

The Tax Administrator requests authorization to relieve charges of taxes that are beyond the statute of limitations of 10 years and those vehicles that are more than two (2) years past due. This request is consistent with last year's settlement, which was authorized by the Board.

No citizen may serve more than four consecutive terms for 2-year term boards; three consecutive terms for 3-year term boards; two consecutive terms for 4-year term boards; and one consecutive term for 5 and 6-year term boards in any one position, unless otherwise stated by statute; or there are no other applicants who meet the eligibility requirements. The Equalization and Review Board shall be exempt from these term limits.
