Support for Lease Purchase Transaction of Computer Equipment for

Durham Public Schools**Agenda Text:**

At the September 6, 2018 Durham Public Schools Operational Services and Policy Work Session, the Board of Education approved the purchase of computer equipment using a multi-year lease purchase agreement with Dell Technologies (State Contract Vendor). This transaction requires approval by the Durham Board of County Commissioners as defined under N.C. Gen. Stat. §§ 115C-528 and 115C-441. Installment purchase contracts exceeding a three-year term and \$250,000 in financing are considered “continuing contracts for budgeted funds,” and are subject to approval by the Board of County Commissioners. (See, e.g., N.C. Gen. Stat. § 115C-528(e), (g) and § 115C-441(c1).)

In addition, the repayment term is recalculated each year based on the current year financing charge making the terms less than five years, so the requirement for Local Government Commission approval does not apply since only contracts with terms of five or more years and involving \$500,000 in financing require such approval. (See N.C. Gen. Stat. § 115C-528(f) and § 159-148.)

Durham Public Schools will use annual budgeted funds for this request; therefore, no additional funding from the County is required.

Alignment with Strategic Plan: This project aligns with **Goal 1: Objective 1 - Increase Academic Achievement; 1D** - By 2023, 100 percent of all teachers, leaders, and staff will use technology as a tool for accelerating and personalizing student learning.

18-1082**Award Contract for Architectural/Engineering Services for Upgrades to Northern Durham County Solid Waste Convenience Sites****Agenda Text:**

The Board is requested to authorize the County Manager to enter into a contract with HDR Engineering Inc. of the Carolinas to provide architectural upgrades to the two Northern Solid Waste Convenience Sites. This would include consolidating these sites from two leased properties into one County owned property. The development of this new convenience center will meet the long-term demands of the growing community and provide flexibility for future service changes to the waste and recycling programs. The County also desires to improve safety for residents and staff at the site by providing better separation of public traffic and material storage areas and access routes.

On August 11, 2018 a Request for Qualifications (RFQ No. 19-007) for Architectural Services for Upgrades to Northern Durham County Solid Waste Convenience Sites was advertised and mailed to potential proposers. HDR Engineering Inc. of the Carolinas was the selected firm. HDR's proposed budget includes 29 percent M/WBE participation (See Attachment A, Page 8)

Alignment With Strategic Plan: Durham County Government is responsible for providing solid waste services to unincorporated residents in Durham County which includes curbside recycling, litter control and abatement, and the management of residential convenience sites. These responsibilities align with Strategic Plan Goal 4: Environmental Stewardship and Goal 5: Accountable, Efficient and Visionary Government.

one position, unless otherwise stated by statute; or there are no other applicants who meet the eligibility requirements. The Equalization and Review Board shall be exempt from these term limits.
