3. **Feedback on Light Rail Project Sought:** A special note from GoTriangle to community leaders and constituents. The community weighed in, and we listened. Orange and Durham counties' 17.7-mile light-rail project officially entered the federal government's Engineering phase in July 2017, and as engineering has progressed, some beneficial refinements to the initial plans have been identified.

Agenda Text: The Board is requested to recognize Durham County Office of the Sheriff’s Captain Raheem Aleem for saving the lives of two small children in early November.

Being in the right place at the right time is how Captain Raheem Aleem explains what happened when he helped to save the lives of two toddlers on November 1, 2018. “Divine intervention” is what he says took place when he was led to take a different route than originally planned as he returned to Durham from Mebane, North Carolina, Captain Aleem was traveling Interstate 85 just outside of Durham when he saw a SUV flip over after crashing into a guardrail. His quick response to the accident

allowed him to get the children caught in the wreckage out of the car and pass them off to good Samaritans who stopped to also assist. In addition to the children surviving the accident, their mother was also rescued and taken to a nearby hospital where they have been since discharged and recovering well.

Property Tax Releases and Refunds for October 2018

Request for Refund of Excise Tax Paid Pursuant to North Carolina General Statute 105-228.37

Agenda Text:

The Board is requested to refund the overpayment of Excise Tax paid pursuant to North Carolina General Statute 105-228.37 in the amount of \$145. The statute states:” A Taxpayer who pays more tax than is due under this Article may request a refund of the overpayment by filing a written request for a refund with the Board of County Commissioners of the county where the tax was paid. The request must be filed within six months after the date the tax was paid and must explain why the taxpayer believes a refund is due.”

On November 13, 2018, in the Durham County Register of Deeds, a deed was filed with Excise Tax paid in the amount of \$145. On November 14, 2018 the same deed was filed properly in Wake County, North Carolina. (See Attached) Accordingly, a request is hereby made John F. Wible, P.A. for a refund of the stamps improperly paid to Durham County.

The Board is requested to approve the Option Agreement/Offer to Purchase and Contract for 11894 and 12018 North Roxboro Road, Bahama, North Carolina 27503 (parcel ID #s 190536 and 190527) for \$195,000. These parcels combined total 23.44 acres of unimproved land located on the east side of North Roxboro Road (15-501 North) and are owned by Ruth and Carl Whipple. Durham County is purchasing this land for future placement of an expanded Convenience Center to serve residents in the northern areas of the County.

The terms of the Option Agreement/Offer to Purchase and Contract include a Due Diligence Period through January 9, 2019. There is a non-refundable Due Diligence Fee of \$500. The County has the right to terminate the contract during the Due Diligence Period or move directly into the Option to Purchase. The parties agree to hold the Option Period open through August 30, 2019. The Option Fee is \$5,000 and is applied to the purchase price.

Agenda Text: Publication of the Quarterly Management Report (QMR) began nearly four years ago to give the Board of County Commissioners (BOCC) systematic updates on key activities, projects, or issues facing Durham County Government throughout the fiscal year. The document has evolved as our organization began the transition to the Managing for Results (MFR) business model in 2015. The MFR business concept focuses on strategic and operational planning, budgeting for results, managing service delivery, and learning and evaluation. Across the organization, departments have realigned, expanded, or on occasion, discontinued services to meet the strategic plan priorities adopted by the BOCC in June 2017.

This next generation Quarterly Management Report (QMR) has greater emphasis on high priority projects that meet strategic plan goal targets. In upcoming months, expanded performance measurement information, dashboards and other tools will be showcased to inform internal and external customers on critical issues. For example, we have added the ClearPoint Strategy and Microsoft Power BI tools to capture budget and performance measurement information. These enhancements will help us meet desired customer-service goals and more effectively identify areas that need process review, discontinuation or bolstered resources.

No citizen may serve more than four consecutive terms for 2-year term boards; three consecutive terms for 3-year term boards; two consecutive terms for 4-year term boards; and one consecutive term for 5 and 6-year term boards in any one position, unless otherwise stated by statute; or there are no other applicants who meet the eligibility requirements. The Equalization and Review Board shall be exempt from these term limits.
