promoting child health, social justice, and evidence-based policies and programs inspired her to pursue a Master in Public Health (Health Behavior) from UNC Gillings School of Global Public Health. At Gillings, Ms. Bousquette served on the leadership of Classroom to Community, a student organization committed to providing accurate, age-appropriate, and inclusive puberty and sexual health education to students in Durham and co-lead the Child Maltreatment Research and Practice Network.

Prior to attending Gillings, she served as the Child Protection Policy Advisor at World Vision in Washington, D.C, where she led policy and government relations efforts related to violence against children, child labor, and children affected by armed conflict. Ms. Bousquette received a BA in International Studies: Political Science from the University of California San Diego.

At Durham County, Ms. Bousquette will coordinate activities of the Durham ACEs and Resilience Taskforce (DART), contribute to the Early Childhood Action Plan, and identify avenues to increase trauma-informed services within Public Health. Her position is county funded and sits within the Health Education & Community Transformation Division of the Department of Public Health.

# Durham County Sheriff's Office Receives A Full Accreditation From The Council On Accreditation Of Law Enforcement Agencies (CALEA) (10min)

CALEA Accreditation serves as the International Gold Standard for Public Safety Agencies. This accreditation is a continuous process and serves as the foundation for a successful, well managed, transparent, community-focused public safety agency. The Durham County Sheriff's Office has been accredited through CALEA since 1998. The process of CALEA Accreditation begins with a rigorous self-assessment, requiring a review of policies, practices and processes against internationally accepted public safety standards. This is followed with an assessment by independent assessors with significant public safety experience. Additionally, public feedback is received to promote community trust and engagement, and structured interviews are conducted with select agency personnel and others with knowledge to assess the agency's effectiveness and overall service delivery capacities. The decision to accredit is rendered by a governing body of twenty-one Commissioners following a public

hearing and review of all reporting documentation.

# Memorandum of Agreement with the North Carolina Department of Public Safety and Durham County Youth Home

#### Agenda Text:

The Board is requested to approve a Memorandum of Agreement (MOA) with the North Carolina Department of Public Safety (NCDPS) and to authorize the County Manager to sign the MOA. The proposed MOA focuses on an increase in the daily per diem rate for Durham County residents detained at the Youth Home.

The NCDPS has agreed to increase the daily per diem rate for Durham County detainees to \$153.38. The current per diem rate for Durham County residents housed at the Youth Home is \$122.00 per day. The proposed increase aligns with the current daily rate being provided to Guilford and Mecklenburg Counties. The agreement will become effective September 2020 and can be renewed for two additional years.

Juveniles housed in the Youth Home who are residents of other counties and/or charged in other counties will be charged the initial rate of \$244.00 per day per juvenile, with the appropriate county of residence billed by NCDPS for half this cost. The proposed MOA also provides 18 months for the Youth Home to adopt the necessary policies and conduct the necessary training to fully comply with the Prison Rape Elimination Act (PREA), included in Section 24.

Recognizing \$10,000 from the COVID-19 Relief Grant to the Durham

**County Solid Waste Division** 

Agenda Text:

The Board is requested to approve Budget Ordinance Amendment No. 21BCC000048 recognizing \$10,000 from the COVID-19 Relief Grant to the Durham County Solid Waste Division. The COVID-19 Relief Grant, made available by the North Carolina Department of Environmental Quality, provides funding to local governments to support residential recycling programs that have been impacted by the COVID-19 pandemic.

The County will use the money to purchase additional Personal Protective Equipment (PPE) for Staff, update signs and brochures to include Covid-19 related changes, and purchase a limited number of small recycling bins to encourage participation in the "glass on the side" recycling program. The optional "glass on the side" program was implemented to help reduce the overall costs of commingled recycling, thereby reducing the solid waste fee increase in the time of the pandemic. The County will provide a \$2,000 cash match which will be funded from Solid Waste operational budget.

Alignment with Strategic Plan: Durham County Government is responsible for properly managing and disposing of the solid waste and recyclable materials generated by residents in the unincorporated areas of Durham County and disposed of at its four solid waste convenience sites. These responsibilities align with Strategic Plan Goal 4: Environmental Stewardship and Goal 5: Accountable, Efficient and Visionary Government.

# Approval to proceed with the IFB for the Northern Convenience Center Project, which will be supported by LOBs funding

#### Agenda Text:

The Board is requested to grant approval to proceed with the Intent For Bid (IFB) for the Northern Durham Convenience Center Project, which will be supported with limited obligation bonds (LOBs) funding. This request is only for the approval to proceed with the IFB. Once a contractor has been selected for the project a subsequent agenda item will be submitted to approve the contract award and request the LOBs funding in a CFA.

On August 11, 2018, a Request for Qualifications (RFQ No 19-007) for Architectural Services for Upgrades to Northern Durham County Solid Waste Convenience Sites was advertised and HDR Engineering Inc was the selected firm. A contract with HDR was entered into on October 22, 2018. On March 19, 2019, an open house was held at the Bahama Ruritan Club to get community feedback on plans for the new center. In November 2019 the County purchased the property located at 11894 N. Roxboro Road to build the consolidated Convenience Site. This new facility will consolidate the two existing leased convenience sites, Rougemont and Bahama, into one County-owned property. The development of this new convenience center will meet the long-term demands of the growing community and provide flexibility for future service changes to the waste and recycling programs. The

County also desires to improve safety for residents and staff at the site by providing better separation of public traffic and material storage areas and access routes. In June 2020, the County amended the contract with HDR to provide bidding assistance and construction phase services for the project. The estimated construction cost from HDR Engineering and Design is \$2,476,733.00.

Alignment with Strategic Plan: Durham County Government is responsible for providing solid waste services to unincorporated residents in Durham County which includes curbside recycling, litter control and abatement, and the management of residential convenience sites. These responsibilities align with Strategic Plan Goal 4 - Environmental Stewardship and Goal 5 - Accountable, Efficient and Visionary Government.

Budget Ordinance Amendment No. 21BCC000047 To Recognize \$25,000 in Governor's Highway Safety Program Grant Funding for the Durham County Sheriff's Office

Agenda Text:

The Board is requested to approve Budget Ordinance Amendment No. 21BCC000047 recognizing \$25,000 in Governor's Highway Safety Program grant funding for the Durham County Sheriff's Office.

The Durham County Sheriff's Office has been awarded \$25,000 in grant funding from the Governor's Highway Safety Program (GHSP). The Governor's Highway Safety Program helps fund efforts of law enforcement agencies to reduce traffic crashes in North Carolina. In terms of traffic related outcomes, Durham County is ranked within North Carolina in the following categories:

- 12th Highest In Overall Fatalities
- 7th Highest In Alcohol Fatalities
- 12th Highest in Unrestrained Fatalities
- 10th Highest In Speed Related Fatalities

The following goals have been identified for this program:

• Reduce the number of traffic fatalities in Durham County by 25% from the 2014-2018 average of 27 fatalities per year to less than 21 fatalities during

FY 2020-2021.

- To reduce the number of alcohol-related crashes by 10% from the 2014-2018 average of 283 crashes per year to less than 255 crashes from October 1, 2020 to September 30, 2021.
- To reduce the number of speed related crashes by 15% from the 2014-2018 average of 547.8 crashes per year to less than 465 crashes from October 1, 2020 to September 30, 2021.

These funds will be dedicated to cover accrued overtime hours for officers working traffic enforcement from October 1, 2020 - September 30, 2021.

# Capital Project Amendment No. 20CPA000016 Appropriating \$30,693 in Funding From Lincoln Community Health Center for the Lincoln Community Health Center Parking Lot Expansion

# Agenda Text:

The Board is hereby requested to authorize the County Manager to appropriate additional funding to the Lincoln Community Health Center Project 47302635DC139 for the purposes of the parking expansion, and to enter into contracts for the Parking Lot Expansion at the Lincoln Community Health Center (LCHC) located at 1301 Fayetteville St., Durham in the amount of \$30,693.00. This action will increase the total project amount - including contracts, fees and contingencies - to \$86,093.00. Funding for this amendment will be provided by Lincoln Community Health Center.

On March 9, 2020, the Board of County Commissioners approved \$55,400.00 in funding from Lincoln Community Health Center for the Parking Lot expansion project and an Engineering contract with Surface 678. Due to the cyberattack and the Covid-19 the contract was executed on July 7, 2020. This Capital project amendment includes modifications to the scope of the project addressing contracts for the following: (1) Offsite Stormwater Analysis. (2) Topographical Survey of Existing

Conditions. (3) Geological Survey of Existing Conditions.

As a result of previous renovations, Lincoln is providing services to an additional 2400 clients which required more than 30 new staff. Additional grants over time have added approximately 50 people to inappropriate existing parking. Staff have been parking on Massey, Spaulding, Linwood, and Merrick Streets. The expanded parking will help to alleviate complaints and provide security for staff. The Existing staff lot has 51 spaces and was constructed when Lincoln had 148 staff. Currently Lincoln employs 242 staff. The new lot would include approximately 50 parking spaces.

Funding for this amendment will be provided by Lincoln Community Health Center. Lincoln has agreed to commit funding to Durham County to be incorporated into a capital project account. Completion of this project will provide a more reliable parking situation for staff by eliminating current parking space deficiencies at this facility. Our intent is to bring a construction contract back to the BOCC, at a later date, once bids are received for this project.

Alignment with Strategic Plan: This project aligns with Goal 5 by providing more efficient service delivery and better customer service through the expansion of the parking lot at this location.
