Agenda Text: The Board is requested to approve Budget Amendment No. 21BCC000097 reclassing the budget of \$201,048 from the Environmental Protection Functional Area and reclassing the budget of \$597,701 from Human Services Functional Area to the

Transportation Functional Area (Total of \$798,749).

Finance and Engineering staff have been working together on how to improve the financial accounting and reporting for Transportation. By moving these costs that are Transportation related to the transportation functional area, it will provide a better method of monitoring these costs and services as well as create more transparency as it relates to transportation costs and funding sources. Because the budget reclass is between functional areas, the reclass requires Board approval. The intent was to appear before the Board earlier in the fiscal year to request approval. However, between the cyber-attack and the pandemic, this request was delayed.

This request has no additional financial impact on the County and requires no additional funding. This is merely a reclass of the current budgeted costs and revenue sources from the current functional area in the transportation functional area. There is no increase in the current budget, nor the budget funding sources. It is technical only.

Two fund centers (County Transportation Demand in Environmental Protection functional area and The Durham County ACCESS in Human Services functional area) will be consolidated to Transportation functional area. Additionally, during FY 2020-21 budget development, the Transportation Manager position was temporarily budgeted in the Engineering Project Management fund center as a placeholder. Since the Transportation Manager is now hired, the budget will be moved from Engineering Project Management in Environmental Protection functional area to the Transportation fund center in the Transportation functional area.

The reclass of the budget is broken down below by functional area, cost center, and the amount:

- Reclass \$150,000 From Engineering Project Management fund center in Environmental Protection Functional Area to Transportation fund center in Transportation functional area
- Reclass \$51,048 from County Transportation Demand fund center in Environmental Engineering functional area to County Transportation Demand fund center in Transportation functional area
- Reclass \$597,701 from Durham Coordinated Transportation fund center in Human Services functional area to Durham County ACCESS fund center in Transportation functional area

The table below summarizes the reclassing requested:

Revenues will be reclassed as well; total revenue of \$731,375 would be reclassed to Transportation functional area. Since revenues are budgeted at the category level, this action does not require a budget amendment.

These expense and revenues will be budgeted under the transportation functional area for future fiscal years

**21-0184** New Durham County Youth Home - Approval of Plat Recombining Two Existing Parcels into One Parcel

Agenda Text: The Board is requested to approve the attached Plat recombining the two existing

parcels of land at the Youth Home site into a single parcel (see Attachment 1.) The existing Youth Home and EOC buildings are currently sited on Parcel 128478 totaling 4.653 acres. The new 36-bed Youth Home facility is larger and necessitates utilizing a portion of adjacent Parcel 128491 totaling 3.401 acres. The recombined single parcel totals 8.054 acres.

The recombination of these two parcels is required to allow the appropriate impervious surface calculations that will be necessary to obtain Site Plan approval and further development of the properties.

# **21-0185** Proposed Relocation of Abandoned "Wiley Jackson May Family Cemetery"

Agenda Text:

The Board is requested to approve the proposed relocation of 2 marked and 8 possible unmarked burial sites located within an abandoned cemetery identified as the "Wiley Jackson May Family Cemetery." The gravesites are proposed to be disinterred from the current location at 802 Virgil Rd, Durham, NC 27703 to be reinterred in Maplewood Cemetery located at 1621 Duke University Blvd, Durham, NC 27701.

The request for Board approval is being made pursuant to NCGS 65-106 by MF DEVELOPMENT LLC on behalf of the current property owners DEES FAMILY LLC (Deed Book 3634, Page 360, Plat Book 202, Page 276) in order to accommodate the sale of the property for subsequent development and to provide better protection for the burials by relocating them to a perpetual care cemetery.

MF DEVELOPMENT LLC has submitted a report to the Durham County Department of Public Health detailing historical and archaeological investigations of the cemetery and documenting due-diligence efforts regarding next-of-kin and public notice requirements per NCGS 65-106(b).

This is a technical amendment to combine the initial project costs (47302635DC138) with the continued project construction costs (47302635DC150). This is to ensure that all transactions related to this capital project settles to one final asset upon completion in the Asset Management (AM) Module in the County's financial system, SAP.

In addition, the source of funding for \$8,367,124 of the existing 300 Block East Main Redevelopment Project (47302635DC150) is being adjusted from a future issuance of 2021 LOBs to a future issuance of Taxable LOBs. The future issuance of Taxable LOBs is specifically for the two parking deck projects (the 300 Block and the 500 Block East Main Redevelopment Project (47302635DC151)). As previously presented, these funds will be initially supported through an interfund loan from the General Fund which in turn will be reimbursed from the issuance of a future Taxable LOBs financing source.

# Food Insecure Families during the COVID Crisis and approve Contract Extension with the Food Insight Group

Agenda Text:

The Board is requested to appropriate \$376,350 of Set Aside Funding and Contract Extension Approval with the Food Insight Group (FIG) to continue home delivered meals through June 30, 2021.

The program, currently funded from September 1- March 31, 2021, is requested to be extended through June 30, 2021. The meals provide support to families who are in need of direct-to-home delivery, focusing on (1) families who work and/or don't have adequate transportation and cannot make it to school pick up sites, or (2) families needing to isolate/quarantine because of family members at high risk from COVID-19. These needs have not abated through the winter months due to continued COVID-related community impacts, including continued unemployment and economic distress and the ongoing need for virtual learning options.

The program has the added benefit of working with local restaurants to provide meals, maintaining jobs, and supporting Durham's economy, focusing on restaurants that are Minority and Women-Owned Business Enterprises. Due to increased need and increased efficiencies in service provision, this period will serve more families, children, and seniors than the previous 3-month period. For the April 1- June 30 time period, the requested funds will provide meals for 275 families (approximately 1,000 children) as well as 200 seniors. In addition, the funding extension will support management of DPS school meals deliveries to over 2,000 children through a coordinated volunteer direct-to-home delivery program, which is growing in complexity with the start of new in-school and virtual learning options on March 15 with approximately 50% of families continuing in virtual learning at that time. The family meals program and the school meals deliveries operate under the name *EAT NC*.

The family meals delivery program will continue to operate with referrals from school personnel, social workers, and other community agencies to identify families most in need of the service, including families that must isolate or quarantine due to COVID-19. Seniors are identified through a referral process through public agencies and community-based organizations and limited self-referral. The program will continue to identify and support children and families who experience food insecurity that has been exacerbated by the COVID crisis along with significant barriers to accessing site-based meal programs who would benefit most from this home delivery program. During this term, EAT NC, along with the County and community partners, will examine transition planning beyond June 30, 2021.

No citizen may serve more than four consecutive terms for 2-year term boards; three consecutive terms for 3-year term boards; two consecutive terms for 4-year term boards; and one consecutive term for 5 and 6-year term boards in any one position, unless otherwise stated by statute; or there are no other applicants who meet the eligibility requirements. The Equalization and Review Board shall be exempt from these term limits.
