Purchase two BioQuell Sanitizing Systems for OES Emergency Vehicles via a Sole Source Vendor - BioQuell, Inc.

#### Agenda Text:

The Board is requested to approve the purchase of two (2) BioQuell "BQ-EMS" bio-decontamination sanitizing systems from sole source BioQuell, Inc. for a total cost of \$66,572 utilizing existing funds within the Office of Emergency Services EMS Division's operating budget. The BQ-EMS system provides another layer of protection and safety for our employees.

BioQuell, Inc. is located in Horsham, PA and is a sole source manufacturer and supplier of the BioQuell BQ-EMS portable bio-decontamination system. A sole source letter has been provided indicating they are the only provider of product without competition. The cost of each system is \$33,286 and the funds are available in the current OES EMS-Division's budget.

BioQuell BQ-EMS is a portable decontamination system that uses hydrogen peroxide vapor technology for emergency vehicles as well as non-emergency transport vehicles. This purchase will allow EMS personnel to sanitize the inside of ambulances routinely, quickly, and thoroughly after patient transports. The BQ-EMS systems will be located at two EMS stations allowing EMS crew members to periodically sanitize ambulances. The process takes two to three hours and eliminates viruses, bacteria and pathogens that may have been brought into the ambulance at any time. In the wake of COVID-19, this process allows our EMS providers to maintain a healthy and clean workspace for both patients and crew members while providing pre-hospital care.

In August 2021, S.L. Warren Library was temporarily closed for extensive repairs resulting from ongoing water intrusion into the facility. The Durham County Engineering Department has taken steps to investigate and identify source(s) of water intrusion by partnering with REI Engineering, a firm specializing in building envelope systems. REI was awarded a design consultant contract in July of 2021 and has prepared construction documents to facilitate a solution to the water intrusion issues that have plagued the library.

Formal bids for the construction repairs were received by the Purchasing Department on Thursday, February 17, 2022. Three (3) general contractors submitted a responsive bid package, which were opened publicly via virtual format. REI Engineering was also in attendance and produced a certified bid tabulation which is attached to this document for reference. Muter Construction submitted the lowest responsive bid (including alternates) in the amount of \$1,858,161.00. The proposed contract total exceeds the current available project funding by \$308,428.25, leaving no funding for additional project related cost such as relocation of books/furniture, 3rd party materials testing, indoor environmental quality testing, HVAC commissioning, construction contingency, etc. Cost for these additional items is estimated to be \$469,703.75, resulting in a project fund deficiency of \$778,132.00.

In addition to the construction repairs related to water intrusion, the library also desires to capitalize on the library's closing by taking action to brighten and refresh the building interiors which is not included in the current envelope repair work. The additional scope includes new furniture throughout, interior finishes, and lighting upgrades that are intended to highlight the historical importance and relevance of S.L. Warren Library in Durham's diverse culture. Performing this added interior scope concurrently with the envelope repair project will mitigate an extended or second library closing. However, given there were no plans for upgrading interiors in the initial project, there is no funding set aside. Preliminary cost estimates suggest an additional \$802,614.00 will be required for this added interior portion of work. The envelope project deficit (\$778,132.00) combined with anticipated costs for interior upgrades (\$802,614.00) results in a total funding need of \$1,580,746.00.

# Standard Non-Reimbursable Utility Contracts for the Extension of the County Sanitary Sewer System

#### Agenda Text:

The Board is requested to authorize the County Manager to execute eight (8) Utility Contracts for extensions of the County sanitary sewer system. These contracts are the County's Standard Non-Reimbursable Contract. Attached are the project location maps (each labeled) and copies of the signed Standard Non-Reimbursable Utility Contracts (each labeled).

- 1. 10 Davis Drive (Project #21-008) Contract with ARE-NC Region 14, LLC to extend the County sewer system by approximately 16 linear feet of 8-inch ductile iron sewer pipe and one manhole to serve 191,100 square feet of laboratory and office space for Beam Therapeutics located at 10 Davis Drive in Durham. The asset is valued at approximately \$928.
- 2. Lumley Road Townhomes (Project #18-008) Contract with Clayton Properties Group, Inc. to extend the County sewer system by approximately 825 linear feet of 8-inch ductile iron pipe, 1,084 linear feet of 8-inch PVC sewer pipe, and twenty manholes to serve the Lumley Road Townhomes, a 93-unit townhome development, located at 5766 Lumley Road in Durham. The asset is valued at approximately \$110,722.
- 3. Genesis (Project #20-016) Contract with TKC-3029 Holdings, LLC to extend the County sewer system by approximately 28 linear feet of 8-inch ductile iron pipe and one manhole to serve a large industrial flex campus, located at 3029 E. Cornwallis Road in Durham. The asset is valued at approximately \$1,624.

- 4. 3404 Page Road (Project #20-020) Contract with Shenandoah Homes to extend the County sewer system by approximately 1,226 linear feet of 8-inch ductile iron pipe, 2,900 linear feet of 8-inch PVC sewer pipe, and thirty-two manholes to serve a 188-unit townhome development, located at 3404 Page Road in Durham. The asset is valued at approximately \$239,308.
- 5. Blue Jay (Project #20-021) Contract with Eli Lilly and Company to extend the County sewer system by approximately 12 linear feet of 8-inch PVC sewer pipe and one manhole to serve 443,121 square feet of industrial research and development space, located at 59 Moore Drive in Durham. The asset is valued at approximately \$696.
- 6. Alexander Commerce Park (Project #21-014) Contract with Trinity Capital Advisors, LLC to extend the County sewer system by approximately 35 linear feet of 8-inch PVC sewer pipe to serve three industrial buildings totaling 441,280 square feet, located on TW Alexander Drive in Durham. The asset is valued at approximately \$2,030.
- 7. 1050 Swabia Court (Project #21-016) Contract with W&G Associates, LLC to extend the County sewer system by approximately 12 linear feet of 8-inch ductile iron pipe and one manhole to serve 79,000 square feet of laboratory and office space, located at 1050 Swabia Court in Durham. The asset is valued at approximately \$696.
- 8. Davis Park East Pod B (Project #20-003) Contract with DD DP Midrise, LLC to extend the County sewer system by approximately 905 linear feet of 8-inch ductile iron pipe and eleven manholes to serve a 381-unit multifamily development with a clubhouse and pool, located at 341 Davis Drive in Durham. The asset is valued at approximately \$52,490.

### **22-0195** Evoqua Water Technologies, LLC Contract Amendment for Utilities Division

#### Agenda Text:

The Board is requested to authorize the County Manager to enter into a service contract amendment with Evoqua Water Technologies, LLC for collection system odor and corrosion control services (RFP 19-035) in the amount of \$3,825.72, bringing the total contract amount from \$76,514.52 to \$80,340.24. Evoqua Water Technologies, LLC increased their pricing by five percent (5%) this fiscal year.

Hydrogen sulfide gases produced by bacteria in the sewer system causes odor and corrosion issues. If untreated, there will be odor complaints from citizens and additional rehabilitation work to pipes and manholes that are corroding.

Alignment With Strategic Plan: This action is in accordance with Durham County Strategic Plan Goal 4: "Environmental Stewardship and Community Prosperity," as this will provide odor and corrosion control within the wastewater collection system resulting in an increase in the useful life of pump stations and gravity sewer lines, thus minimizing the risk of system failures due to corrosion.

Agenda Text:

The Board is requested to approve Budget Ordinance Amendment No. 22BCC00083 appropriating \$1,937,915 in General Fund fund balance to purchase

seven (7) ambulances through the SAVVIK Cooperative Purchasing Agreement for the Office of Emergency Services. This purchase typically would have been a part of the upcoming FY 2022-23 budget, but to secure pricing and more timely delivery the request is being made to encumber this contract a few months prior to the next fiscal year.

During the February 14, 2022, BOCC meeting the Board approved the purchase of five (5) ambulances through the SAVVIK Cooperative Purchasing Agreement. When developing the OES FY 2022-23 budget, the OES - EMS Division reached out to the ambulance vendor to inquire on the cost and delivery date of future replacement ambulances for our aging fleet. The vendor replied that due to sourcing/supply chain issues, costs have increased and any new ambulance request for next fiscal year would not be delivered until mid-2024, which is significantly behind our ambulance replacement schedule.

To keep a healthy and operationally capable fleet, OES is requesting to move up the original replacement schedule from FY 2022-23 to the current fiscal year by purchasing an additional seven ambulances, thus increasing the fleet replacement for FY 2021-22 to twelve. The five originally approved ambulances will continue in the construction schedule at the same cost and capability (Stealth Power anti-idling system installed) as presented during the February 14, 2022 BOCC meeting. The additional seven ambulances will be purchased at the quoted rate of \$276,845 each, and the units will be delivered without the Stealth Power system installed. The Stealth Power unit is also experiencing supply chain issues and will not be available as the new ambulances are manufactured. OES will budget for the installation of the Stealth Power system as part of our FY 2023-24 budget request to ensure our new fleet supports Durham County's environmental stewardship/sustainability initiatives.

The SAVVIK Cooperative Purchasing Agreement is a competitively bid project that Eagle County Health Service District, CO initiated to purchase ambulances and transport vehicles. Braun Ambulances is an authorized provider under the SAVVIK consortium and Spartan Fire and Emergency Apparatus is an authorized dealer for Braun Ambulances. Purchasing the ambulances through the SAVVIK consortium provides Durham County the best value for the Braun Liberty Type I ambulance.

The "Stealth Power" anti-idling system reduces emissions by keeping critical systems and climate control operational without the ambulance having to continuously idle when not responding to calls.

Vehicles in the General Fund are purchased in the Non Departmental Business Area for consolidated tracking of assets, therefore the expenditure will be budgeted in the General Government Functional Area.

### Approval of FY21-22 Contract for Bull City Community Schools Project

#### Agenda Text:

The Board is requested to approve the attached contract for the Bull City Community Schools Project.

The Community Schools Project is a national initiative which seeks to deepen and enhance relationships between schools and the communities within and around them for the mutual benefit of both. Work began on a Durham-focused community schools initiative around 2015 with assistance from the national organization. Eventually, implementation funding was sought from both DPS and Durham County, and from FY18-19 through FY20-21, the Bull City Community Schools Partnership ran a three-year pilot in Durham Public Schools, combining funding and support from DPS, the County (\$120,000 per year), and the national organization. During that time period the work has not expanded greatly across and within Durham Public Schools. The project is currently active at Club Boulevard Elementary and Lakewood Elementary Schools and has a leadership cohort of seven additional principals learning more about the model who may adopt it at their schools in the future.

The project also found a more appropriate fiscal sponsor in the Durham Public Schools Foundation, which took over management of the project in 2019.

The Board of County Commissioners approved \$146,000 in fund balance on Feb. 14th, 2022 as a FY21-22 contribution to this ongoing project, and the attached contract and scope of work cover the work being done in the current year. A request and scope for FY22-23 will also be forthcoming and part of the proposed FY22-23 budget.

Alignment with Strategic Plan: Initiatives which succeed in strengthening our public schools resonate broadly with the Durham County Strategic Plan, but particularly with Goal 1 - Community Empowerment and Enrichment
