Budget Ordinance Amendment No. 23BCC00005 Library to Recognize \$2,488 in Grant Revenue from the State Library of North Carolina to Update Reminiscence Therapy Kits

#### Agenda Text:

The Board is requested to approve Budget Ordinance Amendment No. 23BCC00005 Library to recognize \$2,488 in grant revenue from the State Library of North Carolina (SLNC) to support Durham County Library's Older Adult and Shut-In Services (OASIS) program in their endeavor to renovate their reminiscence therapy kits.

OASIS serves more than 1,800 Durhamites in over 40 nursing homes, senior centers, retirement communities, and other organizations that serve adults living with dementia. Among the most popular resources OASIS provides to the community are reminiscence therapy kits. These kits contain themed audiovisual items, books, and other objects designed to spur interactive connections between adults living with dementia and their caregivers. Though popular, Durham County Library's reminiscence therapy kits are dated, containing slide projectors, cassette tapes, and films on VHS. Grant funds from the SLNC's Bright Ideas program will support the purchase of up-to-date reminiscence therapy kits.

This grant is made possible by funding from the federal Institute of Museum and Library Services (IMLS) under the provisions of the Library Services and Technology Act (LSTA) as administered by the State Library of North Carolina, a division of the Department of Natural and Cultural Resources (IMLS grant number LS-249980-OLS-21).

Alignment with Strategic Plan: This project most aligns with Strategic Goals 1 and 2, community empowerment and enrichment and health and well-being for all. Reminiscence therapy empowers adults living with dementia to connect with their caregivers in addition to improving their health and well-being.

A Utility Contract for the extension of the County Sanitary Sewer System and Reclaimed Water System was approved January 26, 2015. The extension of the County reuse water system is for approximately 10,000 feet of sixteen-inch reuse water line from the south corner of the NC Highway 147/Hopson Road interchange to the south side of Interstate 40 at the HUB RTP (formerly Park Center). The extension of the sanitary sewer system is for approximately 3,700 feet of 24-inch or greater sewer line from the existing 36-inch sewer north of NC Hwy 147 to the south side of Interstate 40 at the HUB RTP.

The lines are being installed in existing County easements, with the exception of the reuse water lines in the Highway 147/Hopson Road interchange. In the interchange area, the lines will be installed in NC Department of Transportation right of way. The County owns reuse water carrier pipe under the NC 147 interchange, installed during the toll road construction project.

The reuse water distribution system extension can serve BASF and the HUB RTP redevelopment project. This extension will also be used for the future expansion of the reuse water system further north into Research Triangle Park.

The extension of the 24-inch or larger sewer line is a replacement of an existing 15-inch and 12-inch sewer line. The existing sewer lines are sufficient to serve the initial phases of the Research Triangle Park redevelopment; however, they will be insufficient to serve subsequent redevelopment projects north of Interstate 40. The 12-inch sewer line, constructed of vitrified clay pipe - subject to root intrusion and groundwater infiltration, shall be removed or abandoned in place. The 15-inch sewer shall be maintained for future parallel use. The larger sewer line extension will be used for the future extension of this main outfall further north into Research Triangle Park to serve future Research Triangle Park development projects.

Concurrent and parallel construction of the reuse water line and the sewer line prior to construction of the HUB RTP improvements is a more cost-effective alternative than installation after the HUB RTP improvements are installed. The construction project will be funded from the Utilities Enterprise Fund restricted unspent System Development Fees and per the approved CIP for the use of these restricted funds and was awarded to Pipeline Utilities, Inc. on April 14, 2021.

Alignment with Strategic Plan: This action is in accordance with Durham County Strategic Plan Goal 4: "Environmental Stewardship and Community Prosperity," as this project will ensure a quality delivery of the HUB RTP Sanitary Sewer and Reclaimed Water Extension Project.

# Approval of Construction Contract with Riggs-Harrod Builders, Inc. for the Administration Building II TV Studio Upfit. Bid No: 22-034

### Agenda Text:

The Board is requested to authorize the County Manager to enter into a contract with Riggs-Harrod Builders, Inc. for the Administration Building II TV Studio improvements, located on the fourth floor of the Durham County Administrative Building II, 201 East Main Street, Durham., in the bid amount of \$262,486.00, and to execute any other related contracts including change orders, if necessary, not to exceed a project cost of \$288,735.00 (See Attachment 1, Pages 1-6).

The TV Studio upfit will allow the County live communication abilities in urgent situations and increase communication of other County activities and goals with improved Audiovisual production equipment. The system has been designed to allow the City of Durham, upon entering into a lease agreement with the County, to perform

live broadcasts from this studio.

**Meeting Agenda** 

The upfit of the TV Studio was advertised in local newspapers on May 25, 2022, and a pre-bid conference and site visit were held on June 1, 2022 at 10:00 a.m. Three (3) bids were received by June 23, 2022, at 2:00 p.m. (See Attachment 1, Page 5, Bid Tabulation Sheet). Riggs-Harrod Builders, Inc. submitted the lowest responsive Bid in the amount of \$262,486.00. Two other bids received were rejected as non-conforming bids, one for including substitutions in their response, which was specifically dis-allowed in the Invitation for Bids, and additionally noted at the Bid Conference, and the other for failing to include required forms in their Bid Response.

This agenda item has been reviewed and approved by the Purchasing Division. Riggs-Harrod Buildiers has identified a total of 1% Black-Owned participation, which does not meet the Durham County Subcontracting Goal of 14.67% for Black/African-Americans, however the vendor is committed to seeking additional M/WBE participation if the opportunity prevails.

The Engineering Department has reviewed the bid proposals with Purchasing, O'Brien/Atkins Associates, PA, and J&A Engineering, the Project Designers and Engineers, and recommends that the County award a contract to Riggs-Harrod Builders, Inc. for this project. Completion of this project will substantially increase functionality for service delivery and increase the television broadcast options providing greater public engagement (See Attachment 1, Page 6).

<u>Alignment with Strategic Plan:</u> The County's TV Studio is a necessary underpinning for the communication of all five Goals of the Strategic Plan. Most directly, the TV Studio will contribute to Goal 5: exceptional customer service and transparency.

Administration to Increase Expense and Revenue Budgets by \$150,000 to Recognize the City of Durham's Equal Funding Amount for the Master Aging Plan and Approve the Master Aging Plan Interlocal Agreement

### Agenda Text:

The Board is requested to approve Budget Ordinance Amendment No. 23BCC00007 to increase expense and revenue budgets by \$150,000 to recognize the City of Durham's equal funding amount for the Master Aging Plan and approve the Master Aging Plan Interlocal Agreement.

Both the City and County of Durham were supportive of, and involved in, the creation of the attached Master Aging Plan, and project which took a number of years before and during the COVID19 pandemic. A new non-profit, Aging Well Durham, has been created as an evolution of the longer standing body, Durham's Partnership for Seniors, to oversee implementation of the plan. The partners creating Aging Well Durham approached the City and County in the spring of 2021 requesting two years of funding to begin implementation.

The creation of the new non-profit and development of an initial scope of work has taken somewhat longer than expected, and no funds were expended in FY21-22. In the meantime, City and County management also agreed that City funds would flow through the County and that the County would be the primary entity contracting with Aging Well Durham. This interlocal agreement is the vehicle through which City funds will come to the County for this purpose. Goal 2 will be the primary home for management responsibility of this agreement and work.

Both the County and the City have appropriated \$150,000 in their respective FY 2022-23 budgets for the Master Aging Plan. This budget amendment will recognize the City's \$150,000 portion of the ILA as both a revenue and an offsetting expense, bringing to total budget for the County to \$300,000. As the County is the contract executor, the entire \$300,000 expenditure needs to be recognized in the FY 2022-23 budget to enter into the contract with Aging Well Durham.

A finalized contract and scope of work between the County and Aging Well Durham has not yet been completed but is the next step in this process and will be brought back to Commissioners this coming fall.

Request to Approve a One-Time Exemption to Article 46 Sales Tax Funding Dedication to Allow Durham Technical Community College to Use \$200,000 for Campus Security Upgrades

Agenda Text:

The Board is requested to approve an exemption to Article 46 Sales Tax funding dedication to allow Durham Technical Community College to use additional funds (\$200,000) to better prepare their campus in the event of a security incident. These funds would be used to purchase the necessary hardware and software to more

efficiently lock down all college facilities in Durham County in the event of an incident.

This purchase, along with the acquisition of security cameras, which have been funded from the federal Higher Education Emergency Relief Fund allocation, will allow the college to implement security measures that have been identified as critical steps based on a recent assessment of readiness and safety in the event of a security incident.

This funding will support the implementation of a system that will allow the lockdown of Durham Tech campus facilities immediately through a centralized system. At the current time, Campus Police must traverse campus to manually lock each exterior door. In situations where immediate action is critical to saving lives, a centralized lockdown function is critical.

Per Board policy a portion of the revenue from Article 46 Sales Tax is dedicated to supporting scholarships for Durham County citizens, over the years small variances in actual spending have occurred resulting in a modest fund balance of \$400,000 being held by DTCC. The Board is being requested to approve a one-time use of these funds to support this security investment.
