Agenda Text:

The Board is requested to approve an amendment to the FY23 Durham Work Program.

As part of the appropriations process for the Durham County Transit Plan, an annual Work Program is developed which includes a budget for the upcoming fiscal year. The Transit Plan Governance Agreement (ILA) determines the process by which the annual budget is developed and approved, and now requires approval by the Durham County Board of Commissioners ("BOCC") and the GoTriangle Board of Trustees.

The Staff Working Group recommended approval of an amendment to the FY23 Durham Transit Work Program on April 19, 2023. The BOCC is requested to adopt the amendment. A memo from GoTraingle Tax District Administration staff is attached describing the amendment. A summary of the amendment is as follows:

- a. Amendment for GoDurham Connect (GoTriangle) Add \$1,208,282 and decrease North Durham Improvements by \$1,208,282
- b. Amendment for Patterson Place Bus Stops Improvement Project (GoTriangle) Adds \$166,459
- c. Amendment for Increased Cost of Existing Service (I.C.E.S.) Calculation (City of Durham) Decreases by \$29,238
- d. Amendment for GoDurham Repower (City of Durham) Adds \$843,180

In total, the amendment increases the FY23 Durham Transit Work Program by \$980,401.

Agenda Text:

The Board is requested to authorize the County Attorney's Office to execute the proposed settlement agreements in DOT v. City of Raleigh, et al (18 CVS 1932) and DOT v. City of Raleigh, et al (18 CVS 3817).

The North Carolina Department of Transportation initiated condemnation litigation against several Defendants, one of whom was Durham County. There have been negotiated settlements proposed, and the Plaintiff as well as three of the Defendants have approved consent to the settlements.

23-0316 Award Contract for Absence Management Provider to The Standard

Agenda Text:

The Board is requested to authorize the County Manager to enter a service contract with The Standard in the amount not to exceed \$59,484, to provide Absence Management Services for leave administration of Family Medical Leave Act and

additional leave types.

The Standard's cloud-based platform integrates the intake, management, and reporting of Family and Medical Leave (FMLA) and other types of leave. Their process via a single point of entry is designed to provide a fair and consistent leave management process that complies with state and federal laws and regulations. The Standard has been serving as the provider for Short-Term and Long-Term Disability Insurances since July 1, 2021 and the ability to streamline and integrate Absence Management with disability insurance lines provided simplification for both Human Resources and enrolled employees as it relates to claim processing of benefits. In addition, the service includes consultation and support for all stakeholders involved in the FMLA process.

23-0332 Joint Partnership with the City of Durham on Affordable Housing Initiatives - Interlocal Agreement

Agenda Text:

The Board is requested to approve an interlocal agreement supporting joint projects with the City of Durham that could address the development of affordable housing. In December 2021, the City of Durham Community Development Department (CDD) issued a Request for Proposals (RFP) under the FHD program to provide gap financing for affordable housing developments utilizing Low Income Housing Tax Credits (LIHTCs) to further the goals of the FHD program.

A total of nine proposals were received for affordable housing projects with an aggregate amount requested of approximately \$40 million for approximately 1,200 units. Of the nine proposals received, the Community Development Department was only able to fund four projects totaling \$16,785,000. The remaining four projects require approximately \$20 million in funding. After April 3, 2023, work session, staff was asked to move forward with an interlocal agreement with the City of Durham to support up to \$10 million in ARPA funding for expanded affordable housing.

Carver Creek Campus Permanent Supportive Housing Funding Approval

Agenda Text:

The Board is requested to approve grant funding to Housing for New Hope for the purpose of acquisition of the Carver Creek Apartments and the development of the Carver Creek Campus for Permanent Supportive Housing.

The Board authorizes the County Manager to work with the City Manager on a joint grant funding solution to be brought back to the Board of Commissioners for consideration at our June 6 Work Session. The Board also authorizes the County Attorney to work with the City Attorney's office to develop any necessary contract and interlocal agreements.

The Board also approves partnering with the Durham City Council to provide grant funding to Housing for New Hope (HfNH) for the acquisition of the 48-unit Carver Creek Apartments. This funding will support:

- 1. Allowing existing residents to remain in their current housing and prevent displacement of current residents.
- 2. Public control and preservation of 48 existing affordable housing units whose 30-year protective covenants will terminate on December 31, 2023.
- 3. The combining of HfNH's 24-unit William Square Permanent Supportive Housing property with the adjacent 48-unit Carver Creek Apartment property. This will create an 11-acre site that will include 72 units of existing affordable housing and additional developable sites with the potential for more than 120 units of permanent supportive housing.
- 4. The density needed for delivery of co located, wrap around and supportive services provided on site to the residents of the Carver Creek Campus for Permanent Supportive Housing.

The current zoning is Office and Institutional (OI). The applicant proposes to change this designation to Science Research Park - Center (SRP-C) to allow for a future Research Triangle Park (RTP) science research use.

The properties are currently designated Commercial and Recreation/Open Space on the Future Land Use Map (FLUM) (Attachment C). The proposed Science Research Park - Center (SRP-C) zoning is consistent with the designated Future Land Use.

Unified **Public Ordinance** to Amend the Durham Hearing An **Development Ordinance** for **Improving Access** and Walkability (20min)

Agenda Text:

The Board is requested to conduct a public hearing and receive public comments on the Unified Development Ordinance Text Amendment, Improving Access and Walkability (TC2100007).

Summary: The purpose of this amendment is to revise the requirements within the Unified Development Ordinance (UDO) to improve access and walkability in Durham. The Durham Planning Commission initiated the amendment during the summer of 2021 and formed a subcommittee to put a draft amendment forward. The amendment proposes various rules for developers which would limit the length of streets and promote more pedestrian connections to nearby, existing networks. It includes updates to the existing connectivity ratio that ensures developers are providing sufficient road and pedestrian networks within new developments and adequately connecting to adjacent areas or neighborhoods. The amendment also includes a new block length component which limits the allowed length of the streets or street blocks that developers may create to help ensure our communities are built to human scale, closely connected, and walkable.

Two motions are required to approve this item:

Motion #1: To adopt an ordinance amending the Unified Development Ordinance, incorporating revisions to Section 13.6 Street Connectivity Requirements; 13.4 Block Standards; 12.3 Streets; and 12.2 Ingress and Egress Requirements effective June 1, 2023; and

Motion #2: To adopt the appropriate consistency statement as required per NCGS § 160D-605.

Public Hearing - Durham County Transit Plan (20min)

Agenda Text:

The Board is requested to hold a public hearing on the Durham County Transit Plan.

The Durham County Transit Plan is required by state legislation that enabled the local option half-cent sales tax for public transit improvements. The plan must be adopted by the Board of County Commissioners, the GoTriangle Board of Trustees, and the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization Board. The plan was first adopted in 2011, with an update in 2017, and was centered around the Durham-Orange Light Rail Transit project. In 2019, GoTriangle discontinued the light rail project, and there is now a need for a new Durham County Transit Plan. The plan will guide the use of approximately \$1.1 billion for public transit improvements over the twenty-year horizon.

The Board is requested to hold a public hearing at the May 8, 2023, Board of Commissioners meeting. Adoption of the plan will be requested on May 22, 2023.

Alignment with Strategic Plan: The development of a new Durham County Transit

Plan aligns with the Environmental Stewardship and Community Prosperity goal of the Strategic Plan by providing better transit services that connect to jobs, education, housing, healthcare, and opportunity.

Agenda Text:

The Board is requested to conduct a Public Hearing to receive comments on the Utilities Division's Draft System Development Fees Analysis performed by Wildan Financial Services.

Background:

Wildan Financial Services prepared a Draft System Development Fee (SDF) Analysis for Durham County to comply with North Carolina House Bill 436 (HB 436) / SL 2021-136. HB 436 / SL 2021-136 requires that local governments utilize a financial or engineering professional to prepare a written analysis to calculate the SDF. SDF cannot exceed the amount derived from the written analysis and the study must be completed at least once every five years. Fees collected will be used for the repair and rehabilitation of existing sewer assets.

Durham County issued a call for public comments from March 15, 2023, to May 1, 2023.

Wildan Financial Services will review all comments received through the public comment period and through the public hearing and finalize the SDF analysis. Once finalized, the Board of County Commissioners will approve the final document for the SDF rates as part of the Fiscal Year 2024 budget process.

A copy of the draft SDF analysis is attached.

System Development Fees will be used to repair and rehabilitate existing sanitary sewer infrastructure to minimize the potential for negative environmental impacts and allow growth for development.
