The Board is requested to approve Budget Ordinance Amendment No. 24BCC00040 Public Health to Recognize \$150,000 from the NC DHHS Division of Child & Family Well-Being, Whole Child Health Section, Child & Family Wellness Unit to Expand the Triple P Positive Parenting Program. This grant supports the Durham County Department of Public Health's absorbing of the Wake County Triple P program. The Wake County Triple P program had historically been funded by John Rex Foundation but lost its funding during 2023. As such, the statewide Triple P system needed to merge the Wake County program into an existing, funded region. Planning on the part of the statewide PSG (Partnership in Strategic Governance) led the system to embed Wake County into the neighboring Durham County Region, under the Lead Implementing Agency of Durham County Department of Public Health. This merger includes a funding increase of \$150,000 to allow for Triple P to sustain the current level of implementation and positive parenting this high-density population in Wake County, with a services higher-than-average population of young families and children. Funds are allocated for the coordinator position salary and fringe, travel expenses, and required Triple P America materials and resources.

24BCC00046 recognizing \$35,066 in grant funding from the 2023 Homeland Security Grant Program (HSGP) to the Durham County Sheriff's Office.

Durham County has been awarded the 2023 Homeland Security Grant Program (HSGP), which will provide funding for bomb technician equipment. The Sheriff's Office is one of 14 bomb squads in North Carolina, and each squad is assigned a specific region in an effort to support explosive mitigation to all 100 Counties. The Durham County HDU is assigned a five county region compiling of Durham, Granville, Person, Orange, and Chatham counties. The Durham County Sheriff's Office serves as the sole bomb squad for this region, which is comprised of an estimated 932,108 residents. Equipment purchased under the HSGP is utilized in a collaborative and regional manner to serve all areas within our region, as such equipment purchased is a regional asset to be utilized by the USDHS, North Carolina Emergency Management, or Domestic Preparedness Region partners and statewide as needed. This is a reimbursement grant with no County match required.

The Board is requested to approve Budget Ordinance Amendment No. 24BCC00052 recognizing \$81,725 from the U.S. Department of Justice, Bureau of Justice Assistance (BJA) for the 2022 State Criminal Alien Assistance Program (SCAAP) and allocate these funds to the Durham County Sheriff's Office to purchase equipment for disaster preparedness and continuity of operations inside the Detention Center, Mental Health First Aid Instructor Training, and the cost for Southern Resource Advisors, LLC to compile Detention Center population data.

SCAAP, which is administered by the Bureau of Justice Assistance (BJA) provides

federal payments to states and localities that incurred salary costs for incarcerating undocumented criminal aliens who have at least one felony or two misdemeanor convictions for violations of state or local law, and who are incarcerated for at least 4 consecutive days during the reporting period. The Bureau of Justice Assistance has announced that Durham County is eligible for the 2022 SCAAP award in the amount of \$81,725.

Based on the terms of the contract, Southern Resource Advisors, LLC will be paid thirteen percent (13%) of the eligible award amount for compiling Detention Center population data. A payment of \$10,624.25 will be made to Southern Resource Advisors, LLC for this purpose. The attached supplemental document outlines how the remaining \$71,100.75 will be utilized.

J & A Engineering conducted a comprehensive performance assessment at the Durham County Detention Center which identified deficiencies across nine separate functional areas. Many of these areas have equipment and technologies that are no longer supported and/or have reached end of life. In FY22, the BOCC approved Capital Project Amendment No.22CPA00019 and Budget Amendment No.22BCC00076 (AAF#22-0142) that appropriated \$4,425,502 to the Sheriff's Office to replace and repair critical infrastructure at the Detention Center.

This project was put out for bid (RFP No.23-046) and received three proposals. Esitech, Inc. was the lowest qualified bidder and ultimately selected to receive the bid award. See attached documents regarding scoring tabulations for all bidders.

The OES-EMS Division has evaluated our training equipment needs and has concluded the current training manikins, TOMMANIKIN EMS Simulators from North American Rescue Simulations, need repair and upgrades to continue to provide exceptional training capabilities to our EMS providers. The cost of new replacement manikins was evaluated against the cost of repair and upgrades to the current training manikins, and it was determined that repairs and upgrades to our existing manikins is a more fiscally responsible approach than purchasing new replacements. The difference in cost for a new manikin is \$95,000 and the cost to upgrade the current model is approximately \$37,584.00, saving the County close to \$60,000.

North American Rescue (NAR) Simulation is the sole source provider for the TOMMANIKIN simulation manikins that the OES-EMS Division currently owns and utilizes.

The Board is requested to approve an Interlocal Agreement (ILA) with the City of Durham for the Northeast Creek Sewer Basin Hydraulic Model and approve use of funding from the Unrestricted Sewer Utility Enterprise Fund from the approved FY 2023-24 budget in the amount of \$700,000 with an amount not to exceed \$900,000. Project Details:

The Northeast Creek sewer basin contains infrastructure owned by both Durham County and the City of Durham, with several interjurisdictional connections, which flow into the County's Triangle Wastewater Treatment Plant (TWWTP). The TWWTP is rated for an average day flow of 12 MGD. Flow is conveyed through approximately 109 miles of City-owned gravity sewer main ranging in size from 8-inch to 30-inch, with 6 lift stations and approximately 2 miles of force main ranging in size from 2-inch to 8-inch. The County-owned system includes approximately 112 miles of gravity sewer ranging in size from 6-inch to 48-inch, with 13 lift stations and approximately 10 miles of force main ranging in size from 2-inch to 20-inch. The hydraulic modeling will focus on gravity sewer mains that are 10-inch diameter and larger, the lift stations and force mains, sewer mains which include a planned flow meter regardless of diameter, all sewer mains downstream of the above features, regardless of diameter.

The project consists of installing and maintaining temporary flow monitors within the wastewater collection system, surveying the selected gravity sewer inverts, forecasting future wastewater flows, and hydraulic modeling services. The wastewater collection system hydraulic model will be used to evaluate the capacity of the exiting sewer system, to determine system needs for future flows, and to develop prioritized capital improvement projects (CIP).

On July 28, 2023, the County closed on the purchase of the property known as the Shoppes of Hope Valley, a shopping center that includes a large vacant anchor space (former Kroger box) that will be occupied by the Durham County Board of Elections, and 26 individual lease spaces. The overall site is approximately 17.31 acres, and Durham County is interested in evaluating the potential for redevelopment of the site. This includes exploring various redevelopment scenarios for the property, including a range of public and private uses and a variety of ownership options, in addition to analyzing the feasibility of attracting private investment for the redevelopment that aligns with the County's goals.

DFI proposes to conduct a comprehensive market and community-driven assessment of the redevelopment potential of the property that includes the shopping center and surface parking areas. This analysis will identify potential opportunities to leverage these assets in the interest of optimizing the County's utilization and prioritizing community economic development goals.

In this phase (phase 1), DFI would perform a pre-development feasibility analysis to understand market conditions, conduct community and stakeholder engagement, and identify viable redevelopment opportunities that would meet public interests. In Phase II, pending the results of this analysis, which would require a separate contract and fee, DFI could assist the County in identifying a private development partner(s) to assist the County in achieving its vision for the redevelopment.

The Pre-development process outlined by the Development Finance Initiative is the process that was used on other redevelopment projects being performed by Durham County. By engaging DFI, County staff intends to determine a long-range plan for the Shoppes at Hope Valley Shopping Center receiving community input on the development, establishing guiding principles for the redevelopment, attracting private sector investment while minimizing public investment, maximizing public interests, and ensuring that future redevelopment enhances the County's existing assets.

It is recommended that the County proceed with Phase I of the Pre-development Process as outlined in the proposal dated October 10, 2023, in the amount not-to-exceed \$144,350.

The US Treasury allocated an additional \$156.4 million directly to 18 local governments and \$24.4 million was provided to five tribal governments in North Carolina. NCPRO is responsible for oversight, administration, and federal reporting for the state's allocation of the ERA funds. Additionally, NCPRO is working with state, local, and tribal governments to coordinate programs and is providing technical assistance where needed.

Please note that the amount approved by the Board of Commissioners on February 14, 2022, was \$7,167,926.40 while the NCPRO contract/Durham County allocation amount was \$7,126,600.19.

Fiscal Year 2022 ERAP NCPRO 2.0 spending totaled \$1,478,731.20 and the Fiscal Year 2023 spending totaled \$3,657,969.40 for a grand total of \$5,136,700.60 through June 30, 2023.

On July 10, 2023, the BOCC awarded the Construction Manager at Risk (C, M @R) Pre-construction Services contract to Samet/ WC Construction Joint Venture. The Pre-Construction Services phase of the project was the first step in the Construction Manager at Risk process in which the contracting team provided cost estimating, constructability reviews, schedule development and value analysis of the project design. For an efficient scheduling process the project has been broken down into (4) packages which are Package A which consists of items which were immediate and long lead time ((Electrical - 1) Generator/ATS and 2) Switchboards, Mechanical - VRF / ERV units, Structural / Misc. Steel Package; Generator /ATS). GMP#1, Package A was approved by the BOCC on October 9, 2023. GMP#2 is required for the completion of the former Kroger box renovation. Package B consists of the remaining packages for the BOE Renovation project thus GMP#2. Following the pre-qualification of subcontractors for Package B, 15 (fifteen) bid packages were received, publicly opened and read by SWC on October 10, 2023. Several packages did not receive the statutory requirement of (3) bids necessary to open them, thus a second bid opening was scheduled for the remaining packages. Twenty-one (21) packages were publicly opened and read by SWC on October 17, 2023. Bids for the various packages in Package B, are incorporated into "Guaranteed Maximum Price #2" (GMP2) proposal submitted for the renovation project. This mode of bidding allows for the timely completion of construction activities and the opening of the facility, currently scheduled for August 2024. GMP's #3&4 for the sitework and roofing and HVAC rooftop unit replacement for the balance of the shopping center will be bid at a later date.

The contractor is currently tracking MWBE participation at 21.8% for subcontractor participation and the Joint Venture is a 80/20 split with Samet/WC Construction with WC Construction an MBE firm receiving an additional 20% of the administrative/project oversight portion of the contract. For M/WBE information (See Attachment 1, page 3). The contractor is also pursuing additional MWBE

participation if the opportunity is available.

GMP#1 totaled \$1,688,650.08 plus the owner's contingency amount of \$47,365.05 totaling \$1,736,015.13 and GMP#2 \$18,763,101.51 (Bid Package B - base bid plus alternates and allowances) and approve the owners construction contingency at (5%) in the amount of \$785,775.60, to execute any other related contracts including change orders if necessary, not to exceed the available budget of \$19,548,877.06. for a combined construction cost of \$21,284,892.19.

<u>Alignment with Strategic Plan:</u> The relocation of various departments into this facility also addresses Goal 5 by providing more efficient service delivery and better customer service.

Creation of a FY 2023-24 Opioid Settlement Fund Budget Ordinance Allocating \$324,500 of Opioid Settlement Funds to the Public Health Department in Support of a New Position and Related Program Services, as Well as Approval of a Required Authorizing Resolution Directing the Expenditure of Opioid Settlement Funds

Agenda Text:

The Board is requested to approve the creation of a FY 2023-24 Opioid Settlement Fund Budget Ordinance allocating \$324,500 of Opioid Settlement funds to the Public Health Department in support of a new Position and related program services, as well as approval of a required authorizing resolution directing the expenditure of Opioid Settlement Funds.

Durham County Department of Public Health (DCoDPH) will use the funds to advance two strategies identified in Exhibit A of the Memorandum of Agreement Between the State of North Carolina and Local Governments on Proceeds Relating to the Settlement of Opioid Litigation: naloxone distribution and syringe services programs. Funds will be used to create a new county Public Health Education Specialist position focused on Harm Reduction, as well as to provide programmatic & harm reduction outreach supplies; purchase naloxone to support distribution through the Durham County Department of Public Health Pharmacy and 3 naloxone vending machines; purchase and calibration of 1 naloxone vending machine; contract staffing to provide outreach by an individual with lived experience; and purchase of safer syringe program supplies for DCoDPH pharmacy and community distribution.

Alignment with Strategic Plan: This grant aligns with Strategic Goal 2: Health and Well-being for all by supporting evidence-based strategies that reduce the risk of overdose among individuals with opioid use disorder or any co-occurring substance use disorder or mental health condition.
