Commissioner Jacobs stated Lois Harvin-Ravin, Veteran Services Director was retiring at the end of April after 13 years of service. County Manager Hager added Ms. Harvin-Ravin would be honored by the County with a resolution.

Commissioner Jacobs highlighted the Biscuits and Banjos Festival held in downtown Durham from April 25<sup>th</sup> – April 27<sup>th</sup> and thanked North Carolina-born artist Rhiannon-Giddens, organizers, local and international artists.

Chair Allam acknowledged the Alph Kappa Alpha Sorority, Incorporated members in attendance at the meeting and thanked the members for their services provided to the community.

Commissioner Jacobs report from the North Carolina Department of Health and Human Services (NCDHHS) Secretary, Dr. Devdutta Sangvai meeting hosted by the North Carolina Association of County Commissioners on April 22, 2025:

County Commissioners from across our state as well as Durham Government Leadership staff were in attendance. Secretary Sangvai and his team alerted us to concerns about proposed changes to the federal Medicaid Program that could put current North Carolinians who receive Medicaid at risk of losing their healthcare coverage and pose possible unfunded mandates and increased costs to counties. While members of Congress, including members of our North Carolina delegation, say they do not intend to "cut" Medicaid, they say they support changes that in effect will be cuts:

- 1. If the federal funding share currently provided to North Carolina is reduced, due to the funding structure in our state, the 650,000 North Carolinians and more than 22,000 Durham residents who just received health care in the past year due to Medicaid Expansion finally being passed in our state, could immediately lose this health care coverage.
- 2. Even though it is a known fact that a majority of Medicaid recipients are either already working or unable to work due to age, disability or because they are children, Congress is considering work requirements with no provision of local funding to implement this. This will be an

expensive and onerous process at the local level with little cost effective or proven positive outcomes.

3. Congress is also considering changing the recertification process to make it more frequent than the current annual cycle. There has even been mention of a monthly recertification. This again would be a huge local expense and enormous and not practical/onerous burden for locally funded DSS departments.

North Carolina has in fact rolled out an effective and efficient Medicaid enrollment and certification process and it is estimated that there is very little potential fraud in our system.

NCDHHS staff shared their concerns that all these proposed changes will have the result of causing many people to lose their benefits and especially negatively impacting rural counties, hospitals and health care providers who are dependent on this source of funding to provide desperately needed care. Currently a third of the people in our state now receive their physical and behavioral health care through Medicaid- more than 3 million people. More than 10% of our population here in Durham- more than 30,000 seniors, children and disabled people receive their physical and behavioral healthcare through Medicaid. Lincoln Community Health Center depends on this funding as does Alliance Behavioral Health and our entire health system.

Secretary Sangvai and his staff as well as NCACC leadership are urging residents to share their stories with our Congressional delegation- Senator Tillis, Senator Budd and Representative Foushee. Congress is back in session right now and will be making budget decisions in the coming days that threaten Medicaid benefits. The message we heard loud and clear in this meeting was that personal stories matter. Our residents need to call and email our North Carolina federal leaders and share their personal stories. I am sharing this report to inform our Board, staff and all Durham residents and sound the alarm to please act on this important issue.

• Item 25-0194 – Commissioner Burton explained for the public that the North Carolina Public School Lottery Fund funding was being used for capital projects including playground renovations and replacement.

Commissioner Jacobs requested to comment on Item 25-0116 and asked Meytal Barak, County Early Childhood Coordinator and Terry David, President of North Carolina Head Start Association to comment on Item 25-0236.

Item 25-0116 – Commissioner Jacobs inquired about the solar farm offsetting approximately 70 percent of the energy cost for Durham County facilities. Tobin Freid, Sustainability Manager responded the solar farm would provide energy to offset approximately 70 percent of the

electricity used in Durham County facilities and the County's goal was 80 percent renewable energy by 2030 and 100 percent renewable energy by 2050.

• Item 25-0236 – Ms. Barak stated the Federal and State funding for Head Start and Early Head Start funding was at risk of elimination and the Board was requested to approve and sign a letter to urge Congress to protect Head Start funding. Mr. David added Durham received 16 million dollars from the Office of Head Start to serve children and families in the community and highlighted the economic impact if the funding was eliminated. Commissioner Jacobs requested to send the support letter for Head Start to Senator Thom Tillis, Senator Ted Budd and Congresswoman Valerie Foushee on Commissioner's letterhead with pictures and signatures.
