Donna Stainback, Citizen

Ms. Stainback stated the land rates in the critical watershed areas were not changed after landowners appealed the value to the Tax Department and inquired about how the value of the land was determined. She added the appeals were going to the Board of Equalization and Review.

Betty Hamilton, Citizen

Ms. Hamilton stated the critical watershed land issues were not addressed by the Tax Department. She added there was no consistency with the land values and no way to determine how the land values were determined.

Keyar Doyle, Tax Administrator, replied he was in contact with the residents. He added of the appeals proceeded ahead of tax staff and were heard by the Board of Equalization and Review. Mr. Doyle stated he would continue to work with his staff and the residents.

Ms. Inman recognized Sheila Dorsett, Program Integrity Supervisor, for her leadership with Durham County, across the state and nation. She added Ms. Dorsett was retiring on July 31st. Ms. Dorsett stated she was proud to represent Durham County on the local, state and national levels and hoped to continue to advocate after her retirement.

25-0416 Resolution – Recognizing UNC Basketball Legend William “Bill” Chamberlin

Commissioner Valentine read the following resolution:

WILLIAM MARTIN “BILL” CHAMBERLAIN

- WHEREAS,** William Martin “Bill” Chamberlain, a pioneer in University of North Carolina at Chapel Hill basketball, died at the age of 75 on July 13, 2025; and
- WHEREAS,** Chamberlain, a long-time resident of Durham, NC, was the second Black varsity basketball player to join the UNC Tar Heels in 1969; and
- WHEREAS,** as a standout player, contributing significantly to the Tar Heels’ success, he led UNC to the Atlantic Coast Conference Tournament in 1971, doing the same the next year also advancing to the Final Four in 1972; and
- WHEREAS,** Chamberlain, paved the way for future UNC basketball legends such as Bob McAdoo, James Worthy, Michael Jordan, Vince Carter, and others; and
- WHEREAS,** during the three seasons Chamberlain was a star player for UNC, he received Most Valuable Player honors for his play at the NIT before receiving second-team All-American accolades during his last year at UNC; and
- WHEREAS,** off the court and in the classroom, Chamberlain was a standout student as well as a civil rights activist who notably supported the improvement of working conditions, wages, and benefits for Black employees following the Cafeteria’s Workers Strike in 1969; and
- WHEREAS,** after his trailblazing basketball career at UNC, he began his professional basketball career with the Kentucky Colonels and the Memphis Tams in the American Basketball Association, and the Phoenix Suns in the NBA. He briefly played in France and later returned to the United States where he became assistant coach at Duquesne University (Pittsburgh), from 1976-1979. Chamberlain held other coaching, teaching, and state government positions until his retirement; and
- WHEREAS,** we respectfully honor the life and legacy of William Martin “Bill” Chamberlain and celebrate his impactful life of service to others.

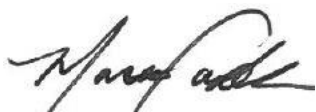
