## 25-0451 Resolution – Honoring the Life of Thomas Henry Krakauer

Commissioner Burton read the following resolution:

#### THOMAS HENRY KRAKAUER

- **WHEREAS,** Thomas Henry Krakauer was born in 1942 in Buffalo New York, to Dr. Hans and Elizabeth Krakauer, and transitioned on June 17, 2025; and
- WHEREAS, he pursued higher education earning a B.S. from the University of Rochester, a M.S. from the University of Miami, as well as a Ph.D. in zoology and physiology from the University of Florida in 1970; and
- WHEREAS, in 1974 he entered the museum field as the director of the Roanoke Valley Science Museum in Roanoke, Virginia and during his time there he grew the facility from a 400-square foot children's museum to a modern regional institution complete with interactive science exhibits and a planetarium; and
- WHEREAS, Tom accepted the position of president and CEO of Durham's Museum of Life and Science in 1985 and increased the museum's annual operating budget from \$675,000 to \$4.2 million dollars; and
- WHEREAS, under his visionary leadership, beloved additions like the Magic Wings Butterfly House came to life, and the Museum grew in both scope and impact. During his tenure, he secured six National Science Foundation grants, which helped shape the Museum's future in informal science education; and
- WHEREAS, he received many awards and honors for his work and was generous with donations to various organizations, including a permanent endowment in memory of his late wife Janet for support of botanical illustration at UNC-Chapel Hill's North Carolina Botanical Garden; and
- WHEREAS, after retiring in 2003, Tom devoted his considerable skills and talents to helping to establish and lead the Museum of Durham History; and
- **WHEREAS,** we pause to honor this remarkable man who will always be remembered as an accomplished birder, butterfly enthusiast, and genealogist and for his "positivity, energy and vision".

## **Other Business**

<u>25-0475 Resolution - Supporting State Funding for the Supplemental Nutrition Assistance Program (SNAP)</u>

The Board read the following resolution:

## RESOLUTION SUPPORTING STATE FUNDING FOR THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM

WHEREAS, the Supplemental Nutrition Assistance Program (SNAP) serves 13% of households in North Carolina (FRAC, 2025). As of July 2025, there are 1,357,112 SNAP participants in NC and 32,660 in Durham County; and

- WHEREAS, four in five families participating in SNAP in NC have either a child, a senior, or an adult with a disability (NC DHHS, 2025); and
- WHEREAS, substantial research has shown that SNAP improves both food security and numerous health outcomes for participants (FRAC, 2017); and
- WHEREAS, every dollar in SNAP benefits generates \$1.50-\$1.80 for local economies (NC DHHS, 2025), and SNAP is especially helpful to the economy during financial downturns; and
- WHEREAS, over 9000 retailers including grocery stores and farmers' markets in NC accepted SNAP and redeemed a total of \$3,974,844,947 in SNAP benefits in 2023 (FRAC, 2025); and
- WHEREAS, SNAP incentive programs at farmers' markets support agriculture, bringing \$500,000 to over 400 NC farmers each year (NCFMN, 2025); and
- WHEREAS, research shows that annual healthcare costs for adult SNAP participants are \$1,400 (or 25%) lower than low-income non-participants (CBPP, 2023), and a study of older adults in NC shows that SNAP was associated with annual Medicaid savings of \$2,360 per person (BD Trust, 2021); and
- WHEREAS, SNAP participation increases access to school meals for NC students through direct certification, and school meals support better health, academic performance, and attendance (SMFANC, 2024); and
- WHEREAS, H.R.1, or the One Big Beautiful Bill Act of 2025, shifted some SNAP benefit costs to states for the first time in the program's history; and
- WHEREAS, the NC Department of Health and Human Services estimates that the cost to North Carolina for this policy change will be \$420 million annually, beginning in FY 2027-2028; and
- WHEREAS, the SNAP program in North Carolina will be eliminated if the state chooses not to pay the increased cost share; and
- WHEREAS, while SNAP benefits currently provide nine meals for every one meal provided by local food banks and pantries across the state, local food banks already report an increase in individuals seeking essential food items and a simultaneous decrease in federal funding for their services, and a reduction in SNAP benefits would further strain food bank and pantry resources; and
- WHEREAS, elimination of SNAP in NC would result in 500,000 children losing automatic qualification for school meals (NCDHHS, 2025); and
- WHEREAS, the additional elimination of federal SNAP-Ed funding in October will further compound food security and economic impacts for NC residents, as SNAP-Ed returns an estimated \$5.36 in health and economic benefits including educational attainment, lifetime earnings, and life expectancy for every for every \$1 spent (NC SNAP-Ed, 2025); and
- WHEREAS, losing SNAP in North Carolina would have devastating impacts on children, disabled individuals, older adults, and working families.

**NOW, THEREFORE, BE IT RESOLVED,** that we the Durham Board of County Commissioners are in support of state funding for the Supplemental Nutrition Assistance Program and call upon the North Carolina General Assembly to approve the estimated \$420 million annual state budget appropriation required to continue the program beginning in FY 2027-2028.

Commissioner Valentine moved, seconded by Vice Chair Dr. Lee to adopt the resolution supporting state funding for the Supplemental Nutrition Assistance Program (SNAP).

The motion carried unanimously.

Raina Goldstein Bunnag, County Food Security Coordinator (Cooperative Extension) thanked the Board for approving the resolution. She stated the resolution was important to residents, businesses and suppliers in the community.

The Board thanked Ms. Bunnag, Maggie Clapp, Director of the Department of Social Services and Dr. Rodney Jenkins, Public Health Director, for their collaboration in helping the residents and the community.

The Board inquired about getting information about SNAP to residents. Claudia Hager, County Manager replied the resolution would help the County to commit to sharing information with residents and elevating the importance of SNAP. The Board asked residents to reach out to their elected representatives about funding for SNAP since the State and Federal levels make the final decisions. The Board asked the Clerk to send the resolution to Federal and State Delegations and Kevin Leonard, Executive Director, North Carolina Association of County Commissioners.

## **Public Hearings**

<u>25-0437 Public Hearing to Consider the Naming Request for William V. "Bill" Bell Lobby</u>
Shannon Trapp, Director of Community Partnership and Engagement shared the *William Bell Lobby Name Request Presentation* which highlighted the following: Durham County Naming/Renaming Policy Highlights, Durham County Naming Committee, Naming Request: William V. "Bill" Bell Lobby, Committee Recommendation and Next Steps.

Chair Allam opened the Public Hearing. With no one signed up to speak, Chair Allam closed the public hearing.

Commissioner Valentine stated Mr. Bell gave his life to Durham County and City by serving as a County Commissioner and the Mayor. He asked the Board to waive the consistency of the County Naming Policy and name a building in honor of Mr. Bell instead of a lobby.

Vice Chair Dr. Lee stated the importance of giving flowers to someone while they were still alive. He stated previously, he did not support naming different attributes in Durham after Mr. Bell, noting the recent street naming ceremony by the City of Durham. Vice Chair Dr. Lee, added after speaking with Dr. Anjanée Bell, daughter of Mr. Bell and limited input from others, he reflected on the matter. He added the naming policy was for staff and the Board could suspend the policy and make a final decision. Vice Chair Lee recommended that the Board suspend the Naming Policy and re-name County Administration Building II after Mr. Bell.

Larissa Williamson, County Attorney stated the Board would need to advertise another public hearing to address the change for a different naming request.

Commissioner Valentine stated for the record, from the start of the process he supported the naming request for a building and not a lobby.

Vice Chair Dr. Lee asked if the public hearing to consider the naming request could be added to the September 8, 2025, Regular Session meeting agenda. Monica Wallace, Clerk to the Board replied yes, adding the public hearing could be advertised for 10 days prior to the September 8<sup>th</sup> Regular Session meeting – those days also including the weekend.

Commissioner Burton stated she supported and approved of the public hearing to consider the naming request at the September 8<sup>th</sup> Regular Session meeting.

Chair Allam asked if the applicant was aware of the public hearing. Ms. Trapp replied yes, adding Dr. Bell was a professor at North Carolina Central University and was teaching a class at the same time as the meeting.
