Commissioner Burton stated she attended the Families and Communities Rising Partnership meeting focused on Head Start and Early Head Start in Durham and Orange County. She added she also attended the North Carolina Transportation Summit and learned about the complex infrastructure challenges in the area and disaster relief.

Commissioner Jacobs stated information about the Low-Income Homeowner’s Relief Program (LIHR) was included with the mailed Durham County property tax bills and enrollment for the program started on September 1, 2025. She added data from the North Carolina Department of Public Instruction indicated nearly 90 percent of Durham Public Schools were earning higher performance grades with more students reaching growth and proficiency goals since the pandemic.

Chair Allam stated GoDurham expanded the Connect’s Microtransit Rideshare Program to offer free rides to the Museum of Life and Science, Edison Johnson Recreation Center, Rock Quarry Park and Duke Regional Hospital.

## Ceremonial Items

### To Be Read/Recognized

#### **25-0494 Proclamation – Six Triple Eight Day**

Commissioner Burton read the following proclamation:

#### **SIX TRIPLE EIGHT DAY | 2025**

**WHEREAS,** during World War II, President Franklin D. Roosevelt created what ultimately become known as the Women's Army Corps (WAC) and at the urging of First Lady Eleanor Roosevelt and Mary McLeod Bethune, Founder of the National Council of Negro Women, African American Women were later admitted to duty, and

**WHEREAS,** recruitment of African American Women into the WAC was limited to 10 percent to mirror the proportion of African Americans in the greater population of the United States, and

**WHEREAS,** a desire to serve in the European Theater of Operations just as their White counterparts led to the creation in 1944 of a Black WAC unit-the 6888th Central Postal Directory Battalion-popularly known as the Six Triple Eight. Notably, dozens of the women who served on the Six Triple Eight were from North Carolina, include Staff Sergeant Mildred Dunn Veasey (Zeta Phi Beta Sorority, Incorporated), and

**WHEREAS,** with upwards of 7 million civilians and military personnel in the European Theater, a backlog of millions of pieces of mail formed and was stored in warehouses in Birmingham, England. The Six Triple Eight was charged with reducing the backlog and boosting troop morale ("No Mail, Low Morale"), by working to sort and route the mail; and

**WHEREAS,** the Six Triple Eight cleared the 6-month backlog in just three Months' time and was next assigned to clear a separate 3-year backlog in Routine, France, and

**WHEREAS,** the 855 African American women who served in the 6888th Central Postal Directory Battalion were honored in Washington, DC at the United States Capitol with a Congressional Gold Medal for their pioneering and devoted military service to our country and to servicemen and servicewomen.

**NOW, THEREFORE BE IT RESOLVED,** I, Nida Allam, Chair and on behalf of the Durham Board of County Commissioners, do hereby proclaim September 13, 2025, as

#### **“SIX TRIPLE EIGHT DAY”**

in Durham County and do commend this observation to the families, friends, supporters and all Carolinians.

## **25-0485 Proclamation – Recovery Month 2025**

### **RECOVERY MONTH | 2025**

- WHEREAS,** National Recovery Month (Recovery Month), which started in 1989, is observed every September to promote and support new evidence-based treatment and recovery practices, the nation’s strong and proud recovery community, and the dedication of service providers and communities who make recovery possible; and
- WHEREAS,** this year’s Recovery Month theme is “Recovery is REAL (Restoring Every Aspect of Life)”; and
- WHEREAS,** it is estimated that 3,025 North Carolinians have died from a suspected overdose in 2024. Durham County seeks to educate the community about substance use disorders, mental health and the availability of services and support; and
- WHEREAS,** we strive to reduce stigma by educating and removing the negative stereotypes associated with the disease of addiction, treatment and programming in hopes that community members recognize that everyone is deserving of help; and
- WHEREAS,** substance use can contribute to illegal activity, the Justice Services Department seeks to invest in recovery programs that address the root causes of the justice involvement by offering programs such as STARR, Jail Mental Health, Cognitive Behavior therapy, Intensive Outpatient treatment and Specialty Courts; and
- WHEREAS,** we strive to reduce the stigma associated with the use of Medication for Opioid Use Disorder (MOUD), by educating the community that MOUD is an evidence- based treatment modality that helps reduce opioid cravings, withdrawal symptoms and the risks of overdose that is used in combination with counseling and/or behavioral interventions; and
- WHEREAS,** we work closely with the City of Durham Community Safety Department and other local, state and federal partners to improve public safety, reduce recidivism and improve the quality of life for justice involved citizens experiencing substance use disorders by offering screenings, assessments, education and group and individual treatment services.

**NOW, THEREFORE BE IT RESOLVED,** I, Nida Allam, Chair and on behalf of the Durham Board of County Commissioners, do hereby proclaim the month of September as

25-0501 Public Hearing - To Consider the Renaming the County Administration II Building after William V. "Bill" Bell

Shannon Trapp, Director of Community Partnership and Engagement shared the *William Bell Lobby Name Request Presentation* which highlighted the following: Durham County Naming/Renaming Policy Highlights, Durham County Naming Committee, Naming Request: William V. "Bill" Bell Lobby, Committee Recommendation and Next Steps.

Chair Allam opened the Public Hearing.

Dr. Anjanée Bell, Applicant

Dr. Bell stated she appreciated the Board taking the time to name a building after her father, William “Bill” Bell. She added her initial request was for a building to be named in honor of her father.

Chair Allam closed the public hearing.

Commissioner Burton moved, seconded by Commissioner Valentine to approve renaming the County Administrative Building II after William V. “Bill” Bell, former County Commissioner.

*I would also like to associate myself with the comments made by Chair Allam. Mayor Bell started his political career at the age of 31, which is the age you are today. This recognition will serve as an inspiration for our young people to consider a life in public service.*

*Mayor Bell is a humble man, and he probably does not like all this attention, but he deserves this great honor. I also want to acknowledge the Bell family, who are present here tonight.*

*Congratulations! Lastly, congratulations, Mayor Bell.*

Chair Allam thanked Mr. Bell’s family for advocating for him and stated Mr. Bell started his political career at a young age and has become a legend.

Commissioner Burton stated naming a County building after Mr. Bell was a historic moment and Mr. Bell’s leadership set a standard in Durham.

Vice Chair Dr. Lee stated the Board was honoring Mr. Bell with the naming of the County building for his leadership and impact on the County and the City.

Commissioner Jacobs thanked Judith Bell, Mr. Bell’s wife and his family for their support and devotion. Commissioner Jacobs shared a brief overview of Mr. Bell’s major campaigns over the years.
