## JOINT MEETING OF THE DURHAM HOMELESS SERVICES ADVISORY COMMITTEE AND THE COUNCIL TO END HOMELESSNESS IN DURHAM (CEHD)

Secretary Bailey stated that instructions would be provided on how to engage in conversation during the breakout sessions.

#### **Subject: Results Team Debriefing**

The group reconvened at 4:20 p.m. and the debriefing session was facilitated by Spencer Bradford (DHCA). At the request of Mr. Bradford, each group gave three good ideas that came from their discussions for moving forward in the coming year.

Chair Forte-Brown expressed her excitement about the meeting of both bodies and thanked all the partners for coming together to find solutions to end homelessness. She stated that another joint meeting would be forthcoming and at that time they will discuss what has been done since this meeting concerning solutions and bettering collaboration. She added that she and Committee Member Love would be reviewing policies in Durham Public Schools involving drug use.

Committee Member Glenn suggested getting everyone's e-mail that participated in the joint meeting. Information from the meeting could then be circulated along with any additional information.
