DURHAM COUNTY MEMORIAL STADIUM AUTHORITY

(Minutes of the November 6, 2012 Meeting)

The Durham County Memorial Stadium Authority (the "Authority") convened at 12:00 noon on Tuesday November 6, 2012 at the Administrative Building BOCC 2nd Floor, 200 Main Street, Durham, North Carolina.

Members present included Chairman Tommy Hunt; Frank Davis; Willie Bradshaw; Durham County Commissioner Pam Karriker; and the undersigned as Recording Secretary. Also present were Reco Chavis, Stadium Manager (the Manager); Carol Hammett, Assistant County Attorney; Motiro Keambiroiro, Director of General Services (the Director).

The following agenda items were considered as follows:

1. Minutes.

The minutes from the May 30 and August 7, 2012 Stadium Authority meetings were approved as submitted.

2. Recognition of new Stadium Authority member.

Omar Beasley was announced as the new Stadium Authority member.

3. Recap of YTD Revenue and Expenses.

The Manager reviewed the year to date statement with the Authority. A large crowd is expected for the CIAA Championship game on November 10. Members of the Authority encouraged the Manager to contact the appropriate personnel at the sheriff department to ensure coordination with the city and state for adequate traffic control for the game.

4. Concession Update.

The bid process for the concession update has taken longer than anticipated. The upgrade is expected to be completed prior to the 2013 football season. The RFP for the concessions will be sent once the concession upgrades are completed.

5. Sidewalk Addition Update.

The Manager provided the members with a map of the proposed sidewalk addition. When completed, the walkway will stretch from the ambulance driveway on the South side, pass in front of the scoreboard, and connect to the North side of the stadium.

6. Current Upcoming Scheduled Events.

The Manager distributed copies of the coming events calendar for the Authority to review. The Authority asked that the Manager prepare an application process for the Authority to review at the February meeting.

Motion was made and approved that all future Stadium Authority regular meetings be held at Durham County Memorial Stadium.

Upon motion the meeting was adjourned.


