Issuance of construction drawing approval does not relieve the financially responsible party/owner of the obligation to obtain any other licenses, permits and approvals as may be required by Federal, State, County or Municipal governments. A Stormwater Permit will be issued upon final inspection and as-built approval. This office must be notified in writing of any change to the information on this form.

- Install and maintain all stormwater control measures
- Inspection and reporting by a registered professional engineer, registered land surveyor, or registered landscape architect, upon the completion of their construction, and annually thereafter.
- Maintain a set of approved stormwater control plans.
- Maintain a performance bond for the life of the project.
- Maintain a valid stormwater permit.
