THE COMMUNITY

Located on the Southern California coast with a culturally diverse population of 3.2 million residents, Orange County offers a high quality of life and a nearly perfect climate year-round. Orange County has thirty-four incorporated cities with seven on these cities among the largest cities in the United States. Orange County offers excellence in education; a low crime rate; a strong, diversified economy; and unlimited recreational opportunities.

Many corporate headquarters and leading technology and biomedical firms have made Orange County their home. John Wayne Airport, owned and operated by Orange County, is conveniently located for business and vacation travelers. Educational opportunities are plentiful with two state universities - California State University, Fullerton, and the University of California at Irvine - plus several private colleges and four community college districts. There are over 60 high school campuses and enough elementary schools to educate 1.5 million students.

Visitors and residents alike have an opportunity to enjoy an abundance of world-class shopping, dining, and resort accommodations, as well as spectacular vistas with 42 miles of pristine, sandy coastline. The region offers a variety of amenities for those that seek an active lifestyle. From fishing to yachting, water sports of every kind abound on the beaches and in the harbors and marinas that dot the Orange County coast. Besides water sports and beaches, the sunny weather is perfect for golfing on world-class courses, hiking, and mountain biking.

Orange County is also home to many of the state's most popular attractions, including Disneyland, Disneyland's California Adventure, and Knott's Berry Farm. The 2002 World Series Champion Angels baseball team and the 2007 Stanley Cup Champion Anaheim Ducks NHL team are exciting choices for sports enthusiasts. Cultural venues are abundant, including the theater, symphony, and orchestra performances and museums for adults and children.

THE COUNTY GOVERNMENT

Orange County is a Charter County governed by a five-member Board of Supervisors elected to four-year terms. The Board is supported by a group of dedicated, appointed or elected department heads. Together, the Board and the 22 departments (and respective divisions) that make up the County government strive to make Orange County a safe, healthy, and fulfilling place to live, work, and play, by providing vital services to the community. The County's core businesses are public safety, public health, environmental protection, regional planning, public assistance, social services, and aviation.

THE PROBATION DEPARTMENT

The Orange County Probation Department enjoys a collaborative and team-focused environment. It has a well-established reputation for seizing opportunities, embracing ongoing education, and providing transparent communication and is dedicated to applying "effective and research supported practices" to help adults and juveniles involved in the justice system and their families successfully navigate and complete probation.

The department is comprised of over 900 employees, more than 600 of whom are sworn staff, and has a FY 2022/23 operating budget of \$209 million. The department includes three bureaus: Adult Operations, Juvenile Operations, and Operations Support. Each bureau is comprised of several divisions with broad responsibilities including, but not limited, to supervising clients in the community and supporting rehabilitation efforts; providing a safe environment for the youthful offenders in custody; ensuring honest, transparent, accurate, and timely communication both internally and externally regarding functions of the department; and providing administrative and fiscal support for all functions.

Additionally, the Probation Department assists the criminal court system through investigations, probation reports, and community supervision of approximately 7,000 adult and 2,000 clients on court-ordered probation or in diversion programs. The Probation Department also operates the Orange County Juvenile Hall and two camps for youth. In addition, there are two Youth Reporting Centers serving North and Central Orange County.

Probation volunteers work in a variety of assignments, often directly with juvenile and adult probationers. Their volunteer service is rewarding as they help to turn lives around, thereby reducing the threat posed by convicted criminal offenders.

ADULT OPERATIONS

The Adult Operations Bureau serves clients released from state prison and county facilities. The division is responsible for supervising these clients in the community, supporting their rehabilitation efforts, and returning them to court if they violate the terms and conditions of their release.

Through extensive and innovative case management, the bureau strives to help clients obtain the skills they need to live crime-free and productive lives. This objective is accomplished by linking clients to services that address their education, employment, substance use, and mental health needs, among others. The bureau also conducts investigations, prepares pre-sentence reports for the court, and represents the Probation Department on various matters. Additionally, the bureau provides specialized services to those convicted of domestic violence and sexual offenses.

The Adult Field Supervision (AFS) Division is responsible for supervising approximately 4,400 adults on formal probation across Orange County. Deputy probation officers (DPOs) support community safety by utilizing accountability and enforcement tools to reduce client recidivism and increase the successful completion of probation. They serve the community by providing treatment and rehabilitation to adult clients and services to victims. In addition to their supervision duties, DPOs provide cognitive behavioral therapy to adult clients such as Effective Practices in Community Supervision (EPICS) which is an evidence-based restructuring tool that teaches clients problem solving

JUVENILE OPERATIONS

The Juvenile Operations Bureau provides oversight and direction of Juvenile Hall and two juvenile camp facilities: the Youth Guidance Center (YGC) and Youth Leadership Academy (YLA). In addition, this bureau is responsible for Probation's two Youth Reporting Centers (YRCs), field supervision of youth on formal probation, and foster care services.

Youth Reporting Centers (YRC) are a collaborative partnership that includes the Orange County Probation Department, Orange County Department of Education (DOE), and the Orange County Health Care Agency Children and Youth Services (HCA). The youth attend a full academic program, participate in afternoon group counseling, individual therapy, and random drug testing with an emphasis on maintaining sobriety. Vocational counseling and life skills development are provided. The YRCs provide an alternative to the traditional detention model under the conditions of the Accountability Commitment Program (ACP). ACP youth receive day for day credit in lieu of secured detention.

The deputy probation officers (DPOs) in the division utilize evidence based, trauma informed, family-focused strategies to aid in the wellness and rehabilitation of youth and families who find themselves involved in the juvenile justice system. Field supervision includes the supervision of youth in the community who have been declared wards of the Court and are on formal probation supervision. Throughout the supervision process, DPOs serve as youth advocates and case managers that monitor the youths' progress on probation. Additionally, the Probation Department connects youth and families with a wide variety of low or no-cost programs and services aimed at limiting or eliminating contact with the juvenile justice system.

SPECIAL SUPERVISION DIVISION

The Special Supervision Division (SSD) supervises the following high-risk client populations: adult and juvenile gang members, adult sex offenders, adult domestic violence clients, and adult high control clients (weapons convictions, violence convictions, history of violence, violent mentally ill). This division provides the following departmentwide services for appropriate populations: Global Positioning System (GPS) Monitoring Center, Supervised Electronic Confinement (SEC), Radio Dispatch Center, Proposition 63 (firearm relinquishment initiative) compliance, Forensic Devices Analysis, and K-9

 $The GPS\,Monitoring\,Center\,oversees\,clients\,on\,GPS\,for\,tracking\,and\,enhanced\,supervision$ purposes and is operated pursuant to Penal Code (PC) 1210.07. SEC is an electronic home detention program for adults (i.e., house arrest) and is operated pursuant to PC 1203.016, where clients committed to a county jail or other county correctional facility, or granted probation, may voluntarily participate in a home detention program during their sentence, in lieu of confinement in the county jail. Additionally, clients under formal supervision may be required to wear a GPS tracking device as an additional term of their

Youth Leadership Academy (YLA) is a 128-bed facility which houses youth ranging from 12 to 25 years old. YLA houses youth that have received custody commitments and have been assessed for transfer to a camp facility.

YOUTH GUIDANCE CENTER

Youth Guidance Center (YGC) is a 5-unit, 125-bed facility offering substance abuse treatment and transitional services for youth of all genders with an age range from 12 to 25 years old. YGC houses youth that have received custody commitments, have been assessed for transfer to camp, and have substance abuse issues.

COURT SERVICES

The Probation Department promotes a collaborative approach to addressing the complex issues of delinquency and criminal behavior through partnerships with federal, state, local, and community- based organizations and agencies.

The Adult Court Services (ACS) Division completes reports related to pre-plea and sentencing investigations for the criminal courts and provides Resident Probation Officers (RPOs) to the Superior Court Justice Centers operating in Orange County. Additionally, the ACS Division processes and monitors a variety of cases subject to Intercounty transfer or Interstate Compact, Pretrial Assessment & Release Supervision (PARS), and Proposition 63 Relinquishment requirements. Division responsibilities also include oversight of Probation's role in the county's collaborative courts, including Drug Courts, DUI Courts, Mental Health Courts, and the Veterans Treatment Court.

The Juvenile Court Services (JCS) Division provides intake screening services for all youth referred by law enforcement agencies for alleged violations of the law; conducts preliminary investigations to determine if further referrals to the District Attorney and Court are necessary; provides Juvenile Court Officers to the Juvenile Court; conducts investigations for the Juvenile Court; participates in collaborative court programs such as Juvenile Recovery Court and the Youth Development Court; supervises youth on Pre-Disposition Program (PPP); and monitors diversion and administrative cases.

Preventing youth from entering the juvenile justice system has a meaningful impact on their overall development and success. For decades, the Probation Department has been actively engaged in diverting youth from the system and toward receiving support at home and within the community through local service providers and other support systems. Creating an environment of trust and advocacy where the Probation Department leverages all available resources to provide youth and their families with services and support throughout the various points of contact within the juvenile justice system likely increases the opportunity for the youth to experience positive behavior change and long-term success.

ADMINISTRATIVE AND FISCAL

The Administrative and Fiscal Division is comprised of the Accounting and Finance Unit, Budget, the Clerical Support and Scheduling Unit, Facilities Support, and Purchasing and Contracts. The division provides administrative and fiscal support services to the entire department. The division is comprised of approximately 285 professional staff who are located at the department's 12 locations and 4 court offices.

Functions within the division include accounting and finance, budget, clerical support for all adult and juvenile operations, purchasing and contracts, facilities support, and grants and donations. During the last fiscal year, the department procured Body and Mail Scanners, TruNarc Drug Detection Devices, 2 Vans in support of OC Cares, new Kitchen Appliances for Juvenile Hall, and ordered 2 Mobile Response RVs to better serve


