- MAT in the Durham County Detention Center

### **Ongoing Activities**

- Identifying strategies reduce stigma for people of color having access to available treatment and diversion programs
- Identifying additional stakeholders to invite to the committee

#### Measures:

- Number of patients entered into treatment
- Decrease in number of OUD-related ED visits (opioid overdose, withdrawal, complications, and infections)
- Number of patients participating in MAT in the Durham County Detention Center
- Increase access to community-based treatment programs upon release

#### **Next Steps:**

- Wait for response from FORE, submitted LOI on August 25, 2019
- Begin MAT in the Durham County Detention Center on September 2, 2019 for those entering the Detention Center currently on MAT
- Continue working with the Bureau of Justice Assistance Grant staff for Technical Assistance in implementing MAT in the Detention Center (Planning Initiative to Build Bridges Between Jail and Community-Based Treatment for Opioid Use Disorder)
- Alliance to provide funding from SOR Grant to expand PSS Services for MAT in the ED, Hospital, and Detention Center until June 30, 2020

 Continue to refer patients to the FIT (Formerly Incarcerated Transition) and STARR (Substance Abuse Treatment And Recidivism Reduction)
