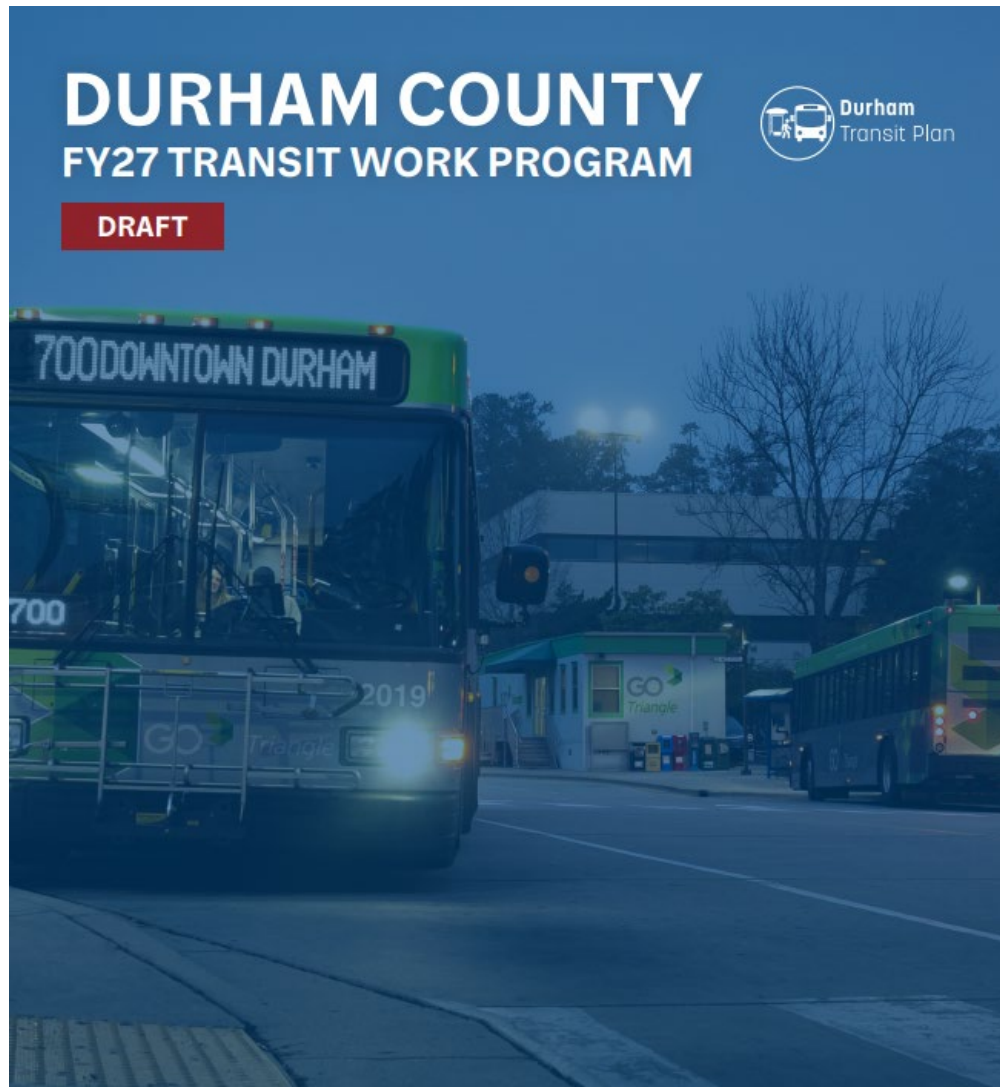

## Executive Summary

The Durham County Staff Working Group (“SWG”) supports the implementation of the Durham County Transit Plan. The SWG has representatives from Durham County, GoTriangle, City of Durham, and the Triangle West Transportation Planning Organization. Each year, the SWG is tasked with developing the Work Program, which is the annual budget for the Durham County Transit Plan. The Work Program includes the projected revenues, expenditures, as well as a Multi-Year Operating and Multi-Year Capital Improvement Plan and begins each year on July 1.

The Draft FY27 Durham County Transit Work Program (“Work Program”) was available for a 21-day public review and comment period from March 27, 2026 through April 17, 2026. The purpose of the public comment period is to share the proposed public transportation investments for the upcoming fiscal year and collect feedback from residents. The SWG Administrator will provide a copy of this report to the SWG and governing boards ahead of the anticipated June 2026 adoption of the final recommended Work Program by the Durham Board of County Commissioners and GoTriangle Board of Trustees.

Public engagement was led by Durham County and included three in-person tabling events, along with digital platforms and printed materials used to promote the public review and comment period. Over the three-week comment period, a total of 80 responses were received through both online and paper surveys.

## Engagement Approach and Results

Public engagement for the Work Program utilized various tactics, including in-person tabling at Durham Station, social media posts, website updates, and an online survey. More details on each component of the campaign may be found below.

### Website

Information was available on Durham County's website ([Annual Work Programs](#)) and via a News Release ([Durham Residents Invited to Provide Input on the Transit Work Program](#)) that was posted on April 2, 2026.

The website included links to the Work Program, a one-page infographic, partner budget priorities, and survey. With the exception of the Work Program, all items were available in English and Spanish.

### Annual Work Programs

The Durham Staff Working Group ("SWG") develops an annual Work Program in accordance with the requirements set forth in the 2023 Interlocal Agreement that was adopted by the Durham Board of County Commissioners, the GoTriangle Board of Trustees, and the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization.

The Work Program is the annual budget for the Durham Transit Plan and includes the projected revenues, expenditures, as well as a Multi-Year Operating and Multi-Year Capital Improvement Plan.

### FY27 Durham Annual Transit Work Program

The Draft FY27 Durham Annual Transit Work Program was released for public review and comment on March 27, 2026. The public comment period closed on April 17, 2026.

The Work Program proposes to allocate \$57 million to transit investments across Durham County between July 1, 2026 through June 30, 2027, to help advance the projects currently adopted in the Durham Transit Plan. This budget includes funding for transit staff, expanded bus service, Bus Rapid Transit (BRT) initiatives, bus stop improvements, new vehicles, and maintenance facility projects.

## In-person Engagement

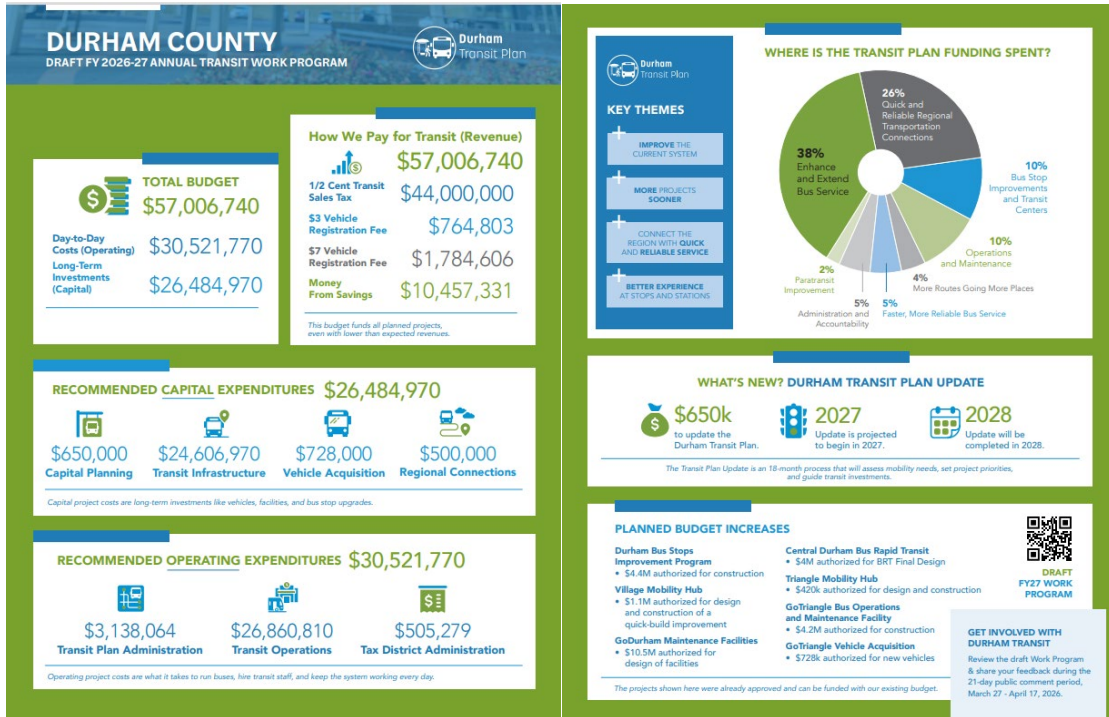
Three tabling sessions were held at Durham Station on the following dates:

1. March 31, 2026, 12:30pm – 2:30pm
2. April 7, 2026, 10:30am – 12:30pm
3. April 16, 2026, 10:30am – 12:30pm

All three sessions were attended by Durham County staff. A public engagement team member from GoTriangle attended the third session. Durham County staff provided an overview of the Work Program to interested parties, and handed out copies of the Work Program infographic, partner priorities, and paper surveys.



The Work Program infographic offers a clear, simple overview of the Work Program’s key elements. It was developed in response to feedback from the FY25 Work Program engagement, where residents noted that the full document was too long and requested a shorter, easier-to-read version.



## Work Program Survey

An online survey was created by Durham County staff using the Survey Monkey platform. It was posted on the Durham County Transportation website for the duration of the engagement period. Paper copies of the survey were available and/or distributed during the in-person sessions at Durham Station. The survey received 80 responses.

The survey consisted of four questions, incorporating both project-specific and open-ended questions. The summary below presents the feedback received for each response.

**1. What should be Durham County's top transit priority for next year's budget, starting in July 2026? Please rank in order of importance. (Response required)**

**5. Please provide any additional comments relevant to the Draft FY27 Work Program.**

#	Survey Comment
1	Concentrate on improving services for users and less on less on unnecessary planning staff
2	Build a train please!
3	What happened to the needs and funding for Paratransit services. Certainly, they are not free and need improvement. Often inefficient with no provision for feedback from the patrons who pay and use the service.
4	As a UNC student who routinely seeks medical care in Durham, I wish there were more options to connect to a bus that would take me from campus to Durham
5	It looks like they are adding plenty of bus stops. The bus stops are not always safe. The lighting around them is inadequate. There tends to be none to little options for people to dispose of trash. There could be more done with ramps and services to help people with disabilities.
6	Transit is one of the most important pillars of good urban design. We need to make sure this is a high priority in order to meet affordability, environmental, and safety goals. It's also not just about the money but getting projects over the finish line with as broad of availability as we can.
7	Durham don't need any BRT buses, I don't think anybody would ride.
8	Would love every weekday, all year, every 30-minute service on the DRX bus between District Dr Park and Ride and Durham Station - and the reverse route!
9	Please prioritize funding for increased service! We need it!
10	As stated previously, I would love to see one bus going back and forth daily to Holly Springs arriving before 7:30 and returning after 9 hours or so. It already costs so much to drive & pay tolls and the crowd making this journey is largely gonna be biotech employees, I'm sure lots of people would make the switch to taking the bus even if fares were high. You could try this for a week and if it doesn't seem to have enough of a riding rate to make it viable, you've at least introduced some people making the same trip who may later carpool together.

#	Survey Comment
11	I would ask that you please consider routing the DRX back to servicing GoRaleigh Station instead of the train station. Durham has its own train station, it makes no sense to go from GoDurham Station on a bus to a train station in Raleigh, or vice versa. Train riders can just travel between train stations. Bus riders generally stick to riding their local & regional bus routes. Connecting local bus routes to regional routes is of utmost importance here. This route change has very negatively impacted bus riders across the region. Thank you for consideration.

## Recommendations

The FY27 Durham Work Program engagement continues to build on recommendations received during the FY25 engagement process, including: (1) providing a fact sheet that highlights major changes in the Work Program, and (2) offering printed survey questions at in-person tabling events.

A key improvement this year was ensuring all engagement materials were available in both English and Spanish. Durham County developed, posted, and distributed all materials in both languages, making them accessible online and at tabling sessions.

As this process continues to evolve, Durham County staff will continue exploring additional opportunities to strengthen engagement and reach a broader number of residents.
