I. INFORMATION ON ACCESSIBLE DENTAL CARE

- Kids and adults should get dental check-ups every six months.
- North Carolina Missions of Mercy Dental Clinics. These clinics are operated by the North Carolina Society and take place for a weekend at a time anywhere in the state—from far western to far eastern NC (generally in churches). The care is completely free and donated by dentists, dental students, and dental hygienists. - Wake, Durham, and Orange County Health Departments. Medicaid will likely cover most dental treatment that a pediatric patient could receive at a health department, and otherwise they would be charged on a "sliding fee" scale (patient provides proof of family income and the health department determines how much they can pay for their dental visit based on their income).
- UNC Dental School has a "lottery system." Parents fill out an application for their children; it can take
 anywhere from 6-9 months to be assigned to a dental student. Definitely a lower-cost option, but also a
 more time-consuming process.

II. LEGAL ASSISTANCE

■ Legal Aid of North Carolina (LANC): http://www.legalaidnc.org/ — LANC is a statewide, nonprofit law firm that provides free legal services in civil matters to low-income people in order to ensure equal access to justice and to remove legal barriers to economic opportunity. LANC operates in all 100 counties in North Carolina through 24 geographically based offices. You must meet income-based eligibility requirements to qualify for the free or reduced representation. For the Durham office, call 1-866-219-5262 (toll free).

Examples of some of cases typically handled by LANC advocates:

 <u>Consumer</u>: Bankruptcy; consumer debt; school loans; defective products; insurance coverage denial; mortgage foreclosure prevention

- o <u>Education</u>: School discipline; student's rights
- o <u>Employment</u>: Unemployment compensation
- o Family: Child custody/visitation; assistance to family violence victims
- o Health: Medicaid, Medicare and/or health insurance problems
- <u>Housing</u>: Eviction defense; illegal lockouts or utility cutoffs by landlords; home foreclosures; housing discrimination; tenants' rights; public or subsidized housing disputes.
- Income Maintenance: SSI/Social Security disability benefits; food stamps; TANF; Special Assistance; Tax assistance
 - NOTE: It is important to remember that because of limited resources, Legal Aid of North Carolina cannot always accept every case listed above for representation.

III. FOOD ASSISTANCE

 Angel Food Ministries is a non-profit, non-denominational organization dedicated to providing food relief and financial support to communities throughout the United States. Their website is www.angelfoodministries.com. There are no qualifications, minimums, income restrictions or applications.

They provide "Angel Food Boxes" of food for \$30 per box; the average retail value of the food provided is \$60. Each month's menu is different than the previous month and consists of both fresh and frozen items. Generally, one box of food assists in feeding a family of four for about one week or a single senior citizen for almost a month. The food is all the same high quality one could purchase at a grocery store. There are no second-hand items, no damaged or out-dated goods, no dented cans without labels, no day-old breads and no produce that is almost too ripe.

Also offered are specialty boxes such as steaks, chicken and pork. Additionally, there is no limit to the number of units or bonus foods an individual can receive, and again, there are no applications to complete or qualifications to which participants must adhere. Angel Food Ministries also participates in the U.S. Food Stamp program, using the Off-Line Food Stamp Voucher system.


