EXPANDING ACCESS TO JUSTICE

eCourts is the package of software applications and technology improvements that will replace the aging network infrastructure with cloud-based applications. Although eCourts has many components, most members of the bar and the public will primarily engage with eFiling and Portal.

eCourts is Live in Lee, Harnett, Johnston, Wake, and Mecklenburg counties.

Twelve more counties (Track 3) will transition to eCourts on **February 5, 2024**: Beaufort, Chowan, Currituck, Camden, Dare, Gates, Hyde, Martin, Pasquotank, Perquimans, Tyrrell, and Washington.

Track 4 includes Alamance, Chatham, Durham, Franklin, Granville, Guilford, Orange, Person, Vance, and Warren counties.

We will begin implementation in early 2024.

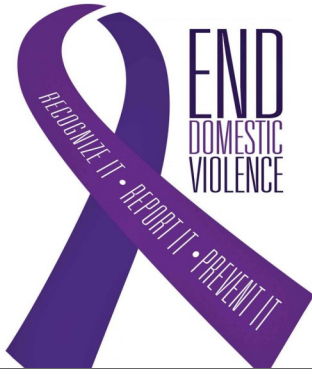

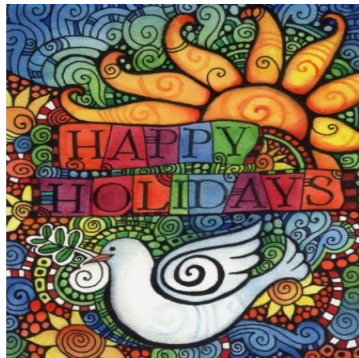
