Assistant County Manager Deborah Craig-Ray called the meeting to order and welcomed everyone to the Board of County Commissioners Worksession. This is indeed a special occasion.

## **Board of Elections Presentation of Certificates**

Mike Ashe, Director, Board of Elections, presented Certificates of Election to the candidates certified as having officially won the November 4, 2008 election.

Mr. Ashe made the following remarks:

"Good Morning, Ladies and Gentlemen. Thank you for letting me share this happy time with you.

I'm Mike Ashe, the Director of Elections. I'd like to introduce Chairman Ron Gregory.

In case any of you are wondering, yes, life is good and getting better.

The purpose of my being here this morning is to present Certificates of Election to the winning candidates as mandated by state law.

L&G, Democracy is alive and well in Durham County. Today's ceremony finishes a wonderful election and democratic process.

I would like to thank Ellen Reckhow for publically recognizing the BOE staff. Your kind words and thoughts were greatly appreciated by the entire Elections family.

Speaking of our Elections family, our staff of seven regular employees, we added 150 one-stop workers and 725 election-day workers. We could not have succeeded without the support of the County staff.

Perry Dixon, Skip Auld, Mike Turner, and Mike Ruffin—because of him, we are properly staffed and funded to do our job.

Democracy had a great couple of months, Durham set new records in every measureable category—number of new registrations, number of pre-election registration updates, number of votes cast, percentage of turnout, number of one-stop votes, and number of absentee by mail ballots.

I am thrilled that so many people made such an effort, some even standing in the cold rain so they could vote for Willie Covington.

L&G have the best vote counting system in the world; publically verified before and after.

People go to a user friendly, ADA compliant voting place and cast a secret ballot without intimidation that is honestly counted and reported.

We were highly scrutinized during this entire process. Because we were an important Presidential battleground state, we had partisan observers in the BOE office and in every one-stop and election-day precinct. We had multiple watchdog groups involved in every aspect of this process.

On November 14, by law, the Board of Elections met in open session to CANVASS or officially certify the results of our election.

This office has not received any written allegations of wrong-doings associated with ballots or counting of ballots. We did not receive any election-day challenges to any voter or any voter registration. I have not received nor am I aware of any charges or protests concerning any elections officials, equipment, or process. We did not have any failure of equipment or personnel that caused doubt on the validity of the process.

To the winners here today, your election was fair and honest. No one has questioned nor can anyone ever question the legitimacy of your victory.

So, on behalf of 137,358 Durhamites, I am honored to present the 2008 Durham County People's Choice Awards. Congratulations, God Bless, and God Speed."

## **Election of Chairman and Vice-Chairman of the Board of County Commissioners**

## **Approval of Public Official Bonds**
