7. <u>Public Hearing to Receive Citizen Comments on the Draft FY 07-08 Annual Action</u> Plan

The Citizen Participation Plan contained in the adopted 2005-2010 Consolidated Plan requires that two public hearings be held prior to the submission of the Annual Action Plan to the U.S. Department of Housing and Urban Development (HUD). The purpose of the first public hearing was to receive citizen comments on housing and community development needs; it was held on January 22, 2007. The purpose of the second public hearing is to receive citizen comments on the City's Draft Annual Action Plan, which specifies the allocation of CDBG, HOME, and ESG funds.

As an entitlement city, Durham has been the recipient of CDBG funds since 1975 and HOME Consortium funds since 1992. CDBG funds have primarily been used for housing activities, public services, code enforcement, and public infrastructure. HOME Consortium funds have been used for affordable housing activities as required by HOME program regulations. Durham has also been a recipient of Emergency Shelter Grant (ESG) funds from HUD, which have been used to provide assistance to individuals and households who are homeless or at risk of becoming homeless.

The Annual Action Plan is Durham's application to the U.S. Department of Housing and Urban Development for the upcoming fiscal year's funding and outlines the actions Durham is taking with HUD-awarded funds to meet the goals as described in the 2005-2010 Five Year Consolidated Plan. HUD regulations require that the City submit the Council-approved Annual Action Plan by May 15. It is DCD's intent to ask Commissioners to approve the Annual Action Plan at the Board of County Commissioner's meeting on April 23, 2007.

8. Public Hearing—The Eastern Durham Open Space Plan

The Eastern Durham Open Space Plan covers the area generally between I-85, US 70 Bypass, US 70, and the Falls Lake. The Eastern Durham Open Space Plan is the third in a series of plans for the preservation of open spaces within the City and County. The Plan seeks to achieve multiple public objectives of providing recreation opportunities, preserving natural beauty, protecting wildlife habitat, preserving historic resources, and maintaining water quality. Implementing the Plan involves public actions in park development, trail construction, and open space acquisition.
