Commissioner Burns announced shea butter lip balm creator kits were available for adults to pick up at the East Regional Library from February 14 – February 19 and registration was required. She also announced the Durham Downtown Feast Month would take place between February 14 – March 13 and invited residents to visit downtown to eat or drink; adding they could qualify to enter and win weekly grand prizes including a \$100 SpendaBull gift card.

Chair Howerton read the following statement:

"In 1926, noted historian and author Carter G. Woodson established "Negro History Week", which later became Black History Month. Because of his dedication and academic work in this area, Woodson became known as the "Father of Black History". He created the Association for the Study of Negro Life and History, which had a goal of encouraging "people of all ethnic and social backgrounds to discuss the Black experience."

The first celebration was held the second week of February and aligned with the birthdays of two persons who significantly impacted to lives of the African American community....Abraham Lincoln and Frederick Douglass. This special month of February now honors the achievements and accomplishments of African Americans, both past, present, and future.

From those early beginnings, the celebration of Black History Month has evolved into a period to celebrate accomplishments, pride, self-discovery, education, innovation, business, political advancements, medicine, science, entertainment and more.

During Black History Month, our nation is reminded of the reality of a systematically oppressed people who have endured generations of injustice, violence, prejudice, and separate treatment all because of their race. But thankfully, changes have occurred to improve the lives of African Americans in America. Significant and important progress has been made on many fronts, yet many challenges remain.

This year's theme is "Black Health and Wellness". How fitting that theme is because we know that the COVID pandemic highlighted the racial disparities in healthcare. Early on we saw the staggering impact of COVID cases and deaths in communities of color.

Harvard professor Dr. David R. Williams noted, "The coronavirus did not create racial inequities in health. It has just uncovered and revealed them." We also understand that there are certain conditions that cause higher rates of death among African Americans including heart disease, cancer, stroke, diabetes, kidney disease, hypertension, homicide and more.

Another critical healthcare issue that needs more attention is Black Maternal Health. Research shows that Black women are three to four times more likely to die from childbirth than their White counterparts. This continues to be an alarming statistic that needs more attention from our nation. We must work to elevate and amplify the conversation to raise awareness and take action to address Black maternal health in all communities. Unfortunately, legislative action on this issue has been slow, but efforts must continue at the local, state and federal level so that we can close this gap.

In this 2022 Black History Month, let us continue to understand how important it is to identify and celebrate our progress, and to note where more efforts are needed. In the words of James Weldon Johnson, the great writer and author of the Negro National Anthem, Lift Every Voice and Sing... "Facing the rising sun, of our new day begun, Let us march on till victory is won". Thank you!"

Items Pulled from the Consent Agenda

22-0060 Renewable Energy Plan Adoption

Claudia Hager, Interim County Manager stated the Board was recommended to adopt the Renewable Energy Plan with the endorsement of the Accelerated Investment scenario option. Vice Chair Jacobs asked how the community would be informed about the plan adoption. Jay Gibson, General Manager responded the Public Information Office would provide a County News Release and a Board of County Commissioners News Release. Tobin Freid, Sustainability Manager added the plan would be available at GreenerDurham.net.

Commissioner Burns stated she hoped a report would be provided to the community after the plan was implemented to show the progress and savings. The Board thanked Ms. Freid and Mr. Gibson for the Renewable Energy Plan.

*22-0088 Budget Ordinance Amendment No. 22BCC000066 Department of Social Services to Recognize Funds in the Amount Of \$7,167,926.40 from both the Consolidated Appropriations Act (CAA) and the American Rescue Plan Act (ARPA) from the North Carolina State Allocation for Durham County to Provide Emergency Rental Assistance Payments for Eligible Families

Vice Chair Jacobs asked William Rose, Department of Social Services Director to share an overview of the Emergency Rental Assistance (ERA-2) Program funds. Mr. Rose stated the funds would be utilized for rent, utility assistance program and housing stability services for families in Durham County. He added Durham County contacted North Carolina Pandemic Recovery Office (NCPRO) to apply for the second round of funds after the first round of funds were exhausted. Mr. Rose stated the dollars would be used to provide funding for the existing qualified applicants; adding, new applications were not being accepted at this time. He stated the County would need to exhaust the funds by 2025 and would use part of the funds to build on the existing rental assistance programs and services.

The Board thanked Mr. Rose and the Department of Social Services staff for their continued devotion to provide and fund needed programs and services for residents.

Commissioner Carter moved, seconded by Commissioner Allam to approve Consent Agenda Items 22-0060 and 22-0088.
