Commissioner Burns read the following proclamation:

- WHEREAS, despite the undeniable impact women have made in history, significant work remains to ensure full equality and access for women and girls everywhere; and

- WHEREAS, a little extra attention is given to women during Women's History Month, however, it important to understand that countless women and girls have been undervalued and inadequately recognized for their contributions to our community, our nation, and our world; and

## 22-0173 Proclamation - Celebrating the 50th Anniversary of the Older American Act Nutrition **Program**

Commissioner Carter read the following proclamation:

## 50<sup>TH</sup> ANNIVERSARY OF THE OLDER AMERICANS ACT NUTRITION PROGRAM | 2022

WHEREAS, fifty years ago, on March 22, 1972, President Nixon signed into law a measure that amended the Older Americans Act of 1965 to include a national nutrition program for individuals 60 years and older; and

- WHEREAS, for five decades, this landmark law has helped to fund community-based organizations like Meals on Wheels – and it is still the only federal program designed specifically to meet the nutritional and social needs of older adults; and
- this year, Meals on Wheels programs from across the country are joining together for the WHEREAS. March for Meals awareness campaign to celebrate 50 years of success and garner the support needed to ensure these critical programs can continue to address food insecurity and malnutrition, combat social isolation, enable independence, and improve health for years to come; and
- WHEREAS, Meals on Wheels Durham has provided home-delivered meals in our Durham County communities admirably for 47 years; and
- volunteers for our Meals on Wheels Durham program are the backbone of the WHEREAS, organization and they not only deliver nutritious meals to seniors and individuals with disabilities who are at significant risk of hunger and isolation, but also caring concern and attention to their welfare; and
- Meals on Wheels programs Durham provides nutritious meals to seniors throughout the WHEREAS. county that help them maintain their health and independence, thereby helping to prevent unnecessary falls, hospitalizations, and/or premature institutionalization; and
- WHEREAS, Meals on Wheels Durham provides a powerful opportunity for social connection for seniors to help combat the negative health effects and economic consequences of loneliness and isolation; and
- WHEREAS, Meals on Wheels Durham deserves recognition for the heroic contributions and essential services they have provided amid the COVID-19 pandemic and will continue to provide to local communities, our State, and our Nation long after it is over; and
- WHEREAS. the senior population is increasing substantially, and action is needed now to support our local Meals on Wheels Durham program through federal, state, and local funding; volunteering; donations; and raising awareness to ensure these vital services can continue to be delivered for another 50 years.

NOW THEREFORE, I, Brenda A. Howerton on behalf of the Durham Board of County Commissioners do hereby proclaim the month of March 2022 as a month to celebrate the

## 22-0159 Proclamation – World Water Day 2022

Vice Chair Jacobs read the following proclamation:

#### **WORLD WATER DAY | 2022**

- **WHEREAS,** the United Nations (UN) has declared March 22nd as World Water Day and has invited governments around the world to devote the day to promoting and increasing public awareness of the importance of freshwater and the sustainable management of groundwater resources; and
- **WHEREAS,** World Water Day 2022 is a time to reflect on the various ways that different people value groundwater around the globe and in North Carolina as it relates to their health, dignity, hygiene and productivity at home, at work, and in recreation; and
- **WHEREAS,** currently, water around the world is under extreme threat for various sources including increasing population, increasing demands of agriculture and industry, and the everworsening impacts of climate change; and
- **WHEREAS,** Durham County residents are working daily to protect water quality by practicing and supporting innovative wastewater management and reuse programs, sustainable agricultural practices, wetland protection and restoration and more.

The Board thanked the Open Space and Real Estate Department, Durham County Utilities Division, the Soil and Water Department, Stormwater and Erosion Control Division and Cooperative Extension for the management of water resources in Durham.

#### 22-0129 Resolution – Support of the Use of Person-First Language

Commissioner Allam read the following resolution:

RECOGNIZING THE HARMEFUL IMPACTS OF THE USE OF PEJORATIVE LANGUAGE TO REFER TO JUSTICE-INVOLVED PEOPLE, AND URGING THE USE OF PERSON-FIRST LANGAGE IN DURHAM

- **WHEREAS**, nearly eighty percent (80%) of the persons held in the Durham County Detention Center are there awaiting trial having not been convicted of the crime they were charged with; and
- **WHEREAS**, people with criminal records endure intense legal and social sanctioning, including segregation, harassment, and harm; and
- **WHEREAS**, individuals with criminal records are part of our communities, schools, workplaces, and places of worship; and
- **WHEREAS**, language shapes the ideas, perceptions, beliefs, attitudes, and actions of individuals, societies, and governments; and
- **WHEREAS**, language usage that emphasizes or prioritizes a criminal record over the individual undermines, devalues, dehumanizes, demoralizes and dishonors the humanity of that individual; and
- **WHEREAS**, dehumanizing language like "prisoner," "convict," "inmate," or "felon" only serve to obstruct and separate people from society and make the institutionalization of racism and supremacy appear normal; and
- WHEREAS, inaccurate information, unfounded assumptions, generalizations, and other negative predispositions associated with justice-involved individuals create societal stigmas, attitudinal barriers, and continued negative stereotypes that affect access to employment, housing, healthcare, professional licensing, travel, support services, and other integral aspects of community life; and
- **WHEREAS**, people-first language places the individual before the criminal record by using neutral, objective, and non-pejorative language; and
- **WHEREAS**, people-first language promotes positive, sound, and unbiased communication and diminishes categorization and segmentation for people with a criminal record, such that an individual is not defined solely or primarily by a criminal record, arrest, or other contacts with the criminal justice system.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Commissioners of Durham County recognizes that language that is not people-first obstructs the integration, inclusion, participation, and respect of justice involved individuals; and

**BE IT FURTHER RESOLVED THAT** that the Board of Commissioners of Durham County requests all local government offices and departments, including the Durham courts and judiciary, and the Durham community at-large to adopt people-first language with respect to people with criminal records in all its official written, voice, audiovisual, and signed communications; and

**BE IT FURTHER RESOLVED THAT** that the Board of Commissioners of Durham County urges adoption and utilization of people-first language in all legislation, co-sponsorship memos, reports, policies, and other documents.

Ben Haas, Chair of the Durham Criminal Justice Advisory Committee thanked the Board for issuing a resolution recognizing the harmful impacts of derogatory language when referring to justice involved residents and urging the use of person-first language in Durham County. He added the resolution was a simply way to bring the community together in a common effort to uplift Durham and protect residents.

The Board thanked Gudrun Parmer, Criminal Justice Center Director, Mr. Haas and the Criminal Justice Advisory Committee for endorsing the resolution. The Board asked about the next steps to implement the resolution. Commissioner Allam stated the drafted languages would be shared with local government offices and departments.

# <u>22-0158 Resolution – Honoring General Manager Claudia Odom Hager's service as Interim County Manager</u>

Chair Howerton read the following resolution:

#### HONORING CLAUDIA ODOM HAGER

- WHEREAS, In May 2021, Durham County Commissioners selected Goal 5 General Manager Claudia Odom Hager to assume the reigns of leadership as Interim Durham County Manager in, thus ensuring that the county's day to day operations would be maintained in a positive manner; and
- **WHEREAS,** Interim Manager Hager made some temporary reassignments and realignments of senior staff, and worked productively to make sure operations proceeded as normal; and
- WHEREAS, throughout her tenure, Interim Manager Hager worked seamlessly and positively with County Commissioners and Department Heads to ensure that normal operations continued as expected by the citizens of Durham County, especially as the organization experienced retirements and resignations in critical areas; and
- **WHEREAS,** her leadership with Durham County Government was marked by her tremendous work ethic, attention to detail, keen negotiating skills, visionary ideas and her ability to work with appointed and elected officials, civic leaders, employees and residents in the pursuit of positive outcomes; and
- WHEREAS, during her successful tenure, her work as Interim County Manager always demonstrated that she was completely mindful of Durham County Government's best interests in all her efforts to serve the community
- **WHEREAS,** during her tenure, Interim Manager Odom successfully addressed very critical and significant Durham County projects including:

Peri Manns, Assistant General Manager/Deputy Director of Engineering and Environmental Services stated the purpose of the contract was for the actual fabrication and installation of the Structural Public Art Screen Wall for the project. He added Global material shortage and supply chain issues increased the cost of the screen wall structure. Mr. Manns stated the screen would serve as a structural purpose required by the Unified Development Ordinance (UDO) for the parking deck as well as meeting the requirements of the County's Art Policy and \$230,000 for the project construction allocated for the parking deck screen would be reimbursed back to the County.

Linda Salguero, Project Manager/Public Art Coordinator stated the artwork would be incorporated into the design and the County followed the Public Artwork Program process. Ms. Salguero shared a video of The Structural Public Art Screen Wall Design Update and Presentation by Uriah Bueller, Chief Executive Officer of Parasoleil and Mike Schock, Design Director of Parasoleil.

The Board asked would the cost of the fabrication and installation of the screen wall be locked-in at \$520,000 if the Board approved the contract. Mr. Manns responded the cost would be close to \$520,000 if the Board approved the contract. The Board questioned if the screen wall was an energy saving design. Ms. Salguero replied the design was for ventilation – she was unsure about the energy savings.
