22-0277 Proclamation – Memorial Day 2022

Chair Howerton read the following proclamation:

MEMORIAL DAY | 2022

- **WHEREAS,** May is designated as Eligibility Workers' Month and taken as an opportunity to recognize Durham County eligibility staff for the significant difference they make in the lives of needy families and individuals, aged adults, foster children, and families in transition; and
- **WHEREAS,** Durham County continues to experience and unprecedented influx of individuals and families requiring services; and
- WHEREAS, despite ongoing stressors including, but not limited to, increasing workloads and caseloads, and system transitions, staff continues to dedicate themselves to make a difference in the lives of those they serve by being compassionate, knowledgeable, and collaborating with community-based organizations to maximize available local resources for the people they serve; and
- **WHEREAS,** eligibility workers support Durham County residents struggling to obtain such basic needs as foods, shelter, healthcare, and transportation; and
- **WHEREAS,** staff effectively fulfill the main mission of the human services profession by enhancing human well-being and helping meet the basic needs of Durham County residents paying particular attention to the needs and empowerment of people who are living in poverty and are vulnerable; and
- WHEREAS, daily, eligibility staff deal with a variety of individuals from various socio-economic, ethnic, and cultural backgrounds, often under adverse conditions and in high stress situations. While working with ever changing complex policies and procedures, staff exercise compassion and patience when dealing with distraught individuals and go above and beyond to ensure that immediate needs are addressed and that expeditated services and benefits are issued appropriately, and

WHEREAS, eligibility staff issues benefits for multiple public assistance programs (Food and Nutrition Services, Medicaid (Adults and Children), and Cash Assistance), and provide program support through Program Integrity, and Foster Care. Eligibility staff also identifies and refer clients in need of other social behavioral, mental health, substance abuse or other services to other department staff, ensure that accurate benefits are issued, provide programmatic training, as well as provide employment assistance to help customers reach self-sufficiency.

Public Hearings

22-0281 Zoning Map Change, Parmer Sector 3 (Z2100013)

Michael Stock, Planning Manager stated Worth Mills of Longleaf Law Partners proposed to change the zoning designation of a portion of one parcel of land located 2102 and 2152 So Hi Drive. He added the entire parcel was split-zoned Rural Residential (RR) and Science Research Park (SRP). Mr. Stock reported the applicant proposed to change the zoning of the RR portion (4.251 acres) to SRP for the entire parcel to be zoned SRP. He added although the application indicated an intent to use the site for office buildings, no development plan was proposed for the request and the UDO did not require a plan for the zoning district.

The Board inquired about the reference of a bike facility. Mr. Stock responded the bike facility was not required and would be addressed with the site plan review. The Board questioned the future land use map showing the adjacent parcel in purple and asked if the changes would affect the wildlife corridor and schools. Mr. Stock responded purple represented industrial; regarding the wildlife corridor and schools a 50-foot barrier and the floodplain would protect the wildlife and the property would not impact schools because it could not be used for residential. The Board inquired about transit services near the parcels. Mr. Stock replied there were no transit services within a quarter mile of the parcels.

Chair Howerton opened the public hearing.

Worth Mills - Attorney

Mr. Mills stated he was representing the applicant and the changes were proposed to create consistent land use for both parcels with intended office and research uses. He added the rezoning for the four (4) acre parcel would allow driveway use on the site. Mr. Mills stated he was working with staff on the site

plan approval.

The Board asked Mr. Mills about the bike facility and environmental features on the parcels. Mr. Mill responded the bike facility was not a requirement and a portion of the site was deemed unusable which would protect the streams and trees.

Chair Howerton closed the public hearing.

First Motion:

Commissioner Carter moved, seconded by Vice-Chair Jacobs to adopt an ordinance amending the *Unified Development Ordinance*, by taking property out of Residential Rural (RR) and establishing the same as Science Research Park (SRP).

The motion carried unanimously.

Second Motion:

Commissioner Burns moved, seconded by Commissioner Allam to adopt the appropriate Statement of Consistency pursuant to NCGS §160D-605.

The motion carried unanimously.

22-0308 Public Hearing on the FY 2022-23 County Manager's Recommended Budget

Chair Howerton opened the public hearing.

Clarence Birkhead, Durham County Sheriff

Sheriff Birkhead stated the Durham County Sheriff's Department was understaffed and a salary increase was needed. He added the difficulty with recruitment and staff retention was due to Durham County not offering a competitive salary. He asked the Board to increase the Sheriff's Department salaries.

Other Business

21-0303 Durham County Public Health Focused Update on the COVID-19 Crisis

Rodney Jenkins, Public Health Director thanked the Board and County Management for their support in the COVID response.

Mr. Jenkins shared the *COVID-19/Vaccine Distribution Update* which highlighted the following: Current COVID-19 Statistics, Current Race and Ethnicity Trends, COVID-19 Percent Positive Labs, COVID-19 Cases Per 100,000 Residents in the Past Seven Days, Usage and Capacity Hospitalization Data, Community Level and Regional Data, Vaccine Updates, Vaccine Dashboard Data for Durham County Residents, Free COVID-19 Testing and Final Thoughts.

The Board questioned the Centers for Disease Control and Prevention (CDC) definition of fully vaccinated and quarantine rules. Mr. Jenkins replied residents were considered fully vaccinated after

receiving two vaccination doses and recommended after positive testing to quarantine for five days and wear a mask if around others in home. The Board asked about reports from wastewater treatment centers. Mr. Jenkins responded one wastewater treatment center in Durham was providing a report. The Board inquired about positive test results data accuracy with home testing. Mr. Jenkins replied, home positive test results were not included in the report data.

22-0290 Update on Family Connects Durham

Robert Murphy, Executive Director; Karen Appleyard Carmody, Director of Early Childhood Prevention Programs; Karen Halpin, Lead Nurse and Venessa Diaz, Family Connects Durham (FCD) Parent and Former Staff Members share the "*Family Connect Durham*" presentation which highlighted the following: Agenda, Who We Are, What is Family Connects, How the Model Works, Family Connects Works for Durham, Families Served 2021 – Ethnicity and Race and Maternal Age, COVID-19 Lessons Learned, Connecting with Families, The Nurse Visit, Community Alignment, Participant Perspective and Discussion.

The Board asked about the race variance for services provided to the community. Ms. Appleyard responded FCD was in the process of replacing the Spanish speaking employee and focused on improving the race variance. The Board inquired about the funding of FCD and the request for County funding. Mr. Murphy replied Duke funded FDC for 17 years and the County contributed funding from the Health Trust and a grant through the Public Health Department.

The Board thanked Mr. Murphy and his team for the presentation and asked that they come back to present at a future Work Session meeting.

22-0291 Proposed Amendment to Durham County's Animal Control Ordinance

Willie Darby, Senior County Attorney stated the Animal Welfare Advisory Committee (AWAC) recommended the proposed amendment to Durham County's Animal Control Ordinance to allow a Trap, Neuter, Vaccinate and Release (TNVR) Program for feral cates to stabilize the cat population, reduce unwanted cat behaviors and the number of new kittens in the community. He thanked Best Friends Animal Society for assisting to review the existing ordinance and providing amendment recommendations. Mr. Darby stated the next steps would include a public hearing, contacting existing TNVR Programs to receive feedback and ask questions about the program. Mr. Darby added a final vote from the Board would be needed along with determining the implementation date.

Chair Howerton opened the public hearing.

Wendy Pinner, Durham County Sheriff Department

Ms. Pinner stated she received calls daily from residents about cats. She added residents called to complain about cats destroying flower beds and gardens, scratching vehicles, removing insulation under homes, urinating and spraying and welfare of the cats.

Dakota Taylor-Beck, Durham County Sheriff Department

Ms. Taylor-Beck asked the Board to not move forward with endorsing the TNVR Program. She added feral cats served as a part of the native wildlife.

Shafonda Allen, Animal Protection Society of Durham

Ms. Allen asked the Board to not consider People for the Ethical Treatment of Animals (PETA) recommendation. She added Durham could offer other options to control and deal with feral cats besides the TNVR Program and euthanatizing

Sharyn Caudell, Citizen

Ms. Caudell stated she opposed the TNVR Program. She added the program supported feral cat colonies in the community.

Mark Manning, Durham County Sheriff Department

Mr. Manning stated he was not condemning the TNVR Program or the ordinance amendment, although the additional work would be added to the Sheriff Department. He added the Sheriff Department would be responsible for the cats while in custody and would need six additional positions.

Chair Howerton closed the public hearing.

Mr. Darby thanked Sheriff Birkhead and the Sheriff Department, AWAC, Commissioner Carter, and Gudrun Palmer, General Manager for assisting with the amendment and the recommendations.

The Board thanked Mr. Darby for reviewing the ordinance and presenting the recommendation.

Vice Chair Jacobs moved, seconded by Commissioner Carter to accept the Draft Amended Animal Control Ordinance and to hold the public hearing at the June 13, 2022 or June 27, 2022 Regular Session meeting.

The motion carried unanimously.

Linda Salguero, Project Manager, Engineering and Environmental Services stated the 10 percent contingency was the standard procedure for the County when dealing with new construction projects to ensure the material met specifications and building code in independent testing outside of the general contractor.

He added the unit would be a mobile clinic with modern technology and would allow the Public Health Department to reach residents and provide services in the community.
