Vice Chair Jacobs announced Roy Cooper, Governor of North Carolina proclaimed June 15, 2022, as "World Elder Abuse Awareness Day." She added the Department of Health and Human Services Division of Aging and Adult Services along with the Tringle J Area Agency on Aging were holding a Discussion and Insight World Elder Abuse Awareness Virtual Event on June 15<sup>th</sup> from 9 a.m. – 12 p.m.

### Chair Howerton made the following statement:

"Good evening. Just two summers ago in 2020, when our nation was experiencing a significant civil unrest stemming from racial injustices and inequities related to the death of George Floyd, many activists and community leaders renewed a call to government officials for an official observance of Juneteenth.

I am so pleased that Durham County Commissioners voted to extend this holiday observance to our employees and community members starting in 2021. Next week's holiday will represent the  $2^{nd}$  time our employees will have a chance to celebrate this holiday with a paid day off.

I am delighted to see that number of people officially celebrating this holiday continues to grow year after year.

The bill making Juneteenth a federal holiday was signed into law by President Biden in 2021. Now, this holiday is one of eleven federal holidays recognized nationwide by the United States Government. It is officially called, Juneteenth Independence Day. Just a week ago, North Carolina Governor Roy Cooper signed an Executive Order allowing a day of personal observance leave for State Employees. Those employees

may request this leave for a day of cultural, religious or personal significance, including Juneteenth.

But let me step back just for a moment. Exactly what is Juneteenth? The resolution approved by this Board supporting the creation of the Juneteenth Holiday for our employees described it this way:

Juneteenth commemorates the day freedom was proclaimed to all slaves in the south by Union General Gordon Granger, on June 19, 1865, in Galveston, Texas. That was more than two and a half years after the signing of the Emancipation Proclamation by President Lincoln. Juneteenth has long been celebrated in Black communities and in a variety of ways.

Primarily the purpose is to celebrate the 13<sup>th</sup> amendment abolishing slavery, and also to educate everyone on the significant achievements of members of the African American community whose ancestors were formerly enslaved.

While traditional community events such as parades, cookouts, prayer gatherings, musical performances and historical cultural readings have long been elements of this observance, our nation is also more focused on the significant challenges that continue to exist among descendants of formerly enslaved people.

Those challenges include the pain and burden of systemic racism, economic challenges, environmental racism, the digital divide, healthcare disparities, lack of jobs, mental health challenges, maternal health disparities, affordable housing, unequal justice, and so much more.

At the end of the day, we must continue to work collaboratively within our entire community to seek equity, equality, and justice and to achieve better conditions where all have the same level of opportunity to thrive. Let's work to be the change we want to see.

Yes, our communities will certainly provide many opportunities to celebrate Juneteenth in this coming week. Enjoy your cookouts, BBQ's Fish Frys, Bake Sales, family reunions... whatever you prefer.

Participate in those various cultural events that feed your spirit the most ...be it slam poetry, parades, fashion shows, music, dance, theatre, storytelling, or religious activities. Whatever it is, may we all just have a wonderful time next weekend...together!

#### 22-0344 Proclamation – Thriving and Resilient Communities Week

Commissioner Carter read the following proclamation:

#### RESILIENT AND THRIVING COMMUNITIES WEEK | 2022

- **WHEREAS,** resilient and thriving communities are vital to our county's future health, success, and prosperity to ensure a strong foundation for everyone at all ages and stages of life; and
- **WHEREAS,** the science is clear that resilience is built, and that communities and systems play a key role in promoting safe, secure, nurturing environments for all; and
- **WHEREAS,** adverse childhood and life experiences, adverse community environments, and adverse climate events impact overall quality of life and wellbeing of an entire community; and
- **WHEREAS,** it is our collective responsibility to promote positive experiences, secure relationships, and supportive environments to buffer stress and adversity; and
- **WHEREAS,** investing in policies, programs, and strategies that address adversity, promote positive experiences in culturally affirming ways, and strengthen community resilience is essential to the health and wellbeing of our county; and
- **WHEREAS,** the Durham community has a long history of addressing adversity, addressing underlying causes of adversity, and promoting resilience; and
- **WHEREAS,** 25 percent of Durham residents in 2019 reported that they did not receive the social emotional support they needed; and
- **WHEREAS,** racism is an adverse childhood experience and drives disproportionate experiences of adversity in childhood; and
- **WHEREAS,** Durham County encourages all agencies, schools, faith-based organizations, healthcare systems, elected leaders, businesses, nonprofits, community-rooted organizations, and individuals to collaborate to strengthen our communities.

**NOW THEREFORE**, I, Brenda A. Howerton on behalf of the Durham Board of County Commissioners do hereby proclaim June 6 – 12, 2022 as

#### "RESILIENT AND THRIVING COMMUNITIES WEEK"

in Durham County and encourages all residents to become informed about the impact of adversity and the benefit of promoting positive experiences and resilience to create a county aware of and actively practicing resilience strategies that benefit all individuals toward communities of hope and healing.

Rod Jenkins, Public Health Director thanked the Board for the proclamation and the recognition. Jessica Bousquette, Adverse Childhood Experiences (ACE) Coordinator thanked Durham County for joining 14 counties across the state with approving the proclamation and commitment to a thriving and resilient community. She shared an overview of the events and projects the Durham ACEs Resilience Taskforce accomplished over the last two years. Dr. Wanda Boone, Founder of Together for Resilient Youth (TRY) stated resilience brought the community together in a respectful, honest and compassionate way and the proclamation was needed after the effect of the pandemic on the community. She added the TRY Community Health Workers and Ambassadors were embedded, familiar and represented the Durham community.

The Board thanked Mr. Jenkins, Ms. Bousquette and Dr. Boone for bringing the proclamation to the Board and continuing to support the community by helping youth and families connect to available services and programs. The Board was proud of Durham County for prioritizing the ACE Program and asked Ms. Bousquette to provide a presentation at a future Work Session meeting.

#### 22-0358 Proclamation – June 2022 as Pride Month

Each Commissioner read a portion of the following proclamation:

#### PRIDE MONTH | 2022

- WHEREAS, the Stonewall Riots, a period of protests and violent clashes with law enforcement in June 1969, is referred to as the genesis of the modern gay rights movement in this country and Pride Month is the result: and
- WHEREAS, Pride Month is also an opportunity to peacefully protest and raise political awareness of current issues facing the community, and to celebrate the history, culture, and contributions of LGBTQ individuals; and
- over the years, we have seen strides made to value members of the LGBTQ community, WHEREAS, and the work to improve their quality of life by first acknowledging the challenges that are faced in all areas of life; and
- WHEREAS, despite extraordinary progress, LGBTQ Americans still face discrimination simply for being who they are, and the County of Durham stands with the community in the struggle to ensure equal treatment for all, while also defending and advocating for LGBTQ Rights as Human Rights; and
- WHEREAS. Durham County Government continues to advocate for state local and statewide protections for all LGBTQ individuals to make our state a place where all people regardless of their sexual orientation, gender identity, or gender expression – are treated with dignity and respect; and

**WHEREAS,** like many progressive communities, the support of LGBTQ Rights is illustrated by the fact that the Durham County Non-Discrimination Ordinance was approved by the Board of Commissioners to provide protection and promote the equal treatment of all individuals and will take effect in July; and

WHEREAS, the ordinance establishes protections and promotes the equal treatment of all individuals and provides freedom from discrimination on the basis of race, ethnicity, creed, color, sex, pregnancy, marital or familial status, sexual orientation, gender identity or expression, national origin or ancestry, marital or familial status, pregnancy, military status, religious belief or non-belief, age, or disability in employment and access to all places of public accommodation.

**NOW THEREFORE**, I, Brenda A. Howerton, Chair and on behalf of the Durham Board of County Commissioners, do hereby proclaim June 2022 as

#### "PRIDE MONTH"

in Durham County. We call upon the people of the Durham to recognize the achievements of the LGBTQ community and help to improve the attitudes of society and encourage inclusiveness in Durham County.

Natalie Watson, Deputy Director, LGBTQ Center of Durham thanked the Board for the proclamation and gave an overview of the available services and programs provided by the center. She added the LGBTQ Center was in the process of opening a Youth Center for LGBTQ youth in Durham and invited residents to attend the Pride Out Loud Event at the Durham Central Park on June 17<sup>th</sup> from 3 p.m. – 7 p.m.

The Board thanked Natalie Watson for the providing services and supporting the LGBTQ community in Durham. The Board stated the Parents Bill of Rights filed in the General Assembly would subject health care providers without parental consent to disciplinary action by licensing boards for non-urgent medical treatments for a minor child, including fines of up to \$5,000. The Board stated they would attend the Durham Pride Parade in September and invited County staff to join.

# <u>22-0242 Public Hearing – Unified Development Ordinance Text Amendment, Omnibus Changes</u> <u>17 (TC21000006)</u>

Michael Stock, Senior Planner stated the Board was requested to conduct a public hearing and receive

public comments on the *Unified Development Ordinance Text* Amendment, Omnibus Changes 17 (TC21000006). Mr. Stock gave an overview of the Planning Commission comments.

The Board asked why the affordable housing bonus was changed from reporting to the City and County to reporting only to the City. Mr. Stock responded the updated was done to reflect the compliance and reporting measures adopted by the City for affordable housing through the Community Development Department. The Board inquired about being provided with formal reports provided to the Joint City-County Planning Commission (JCCP). Mr. Stock replied he would inform Sarah Young, Planning Director to provide the Board with formal reports. The Board asked if Planning Commissioner Amandolia comments were addressed and questioned the small lot size concerns. Mr. Stock responded Planning Commissioner Amandolia comments were not addressed; adding the policy was to inform the JCCP first before initiating the public hearing process. With regard to the lot size, Mr. Scott stated the ordinance would allow lot averaging, amending a small lot with a slop and the maximum size of the house and tracking the number of demolished non-historical older homes.

Chair Howerton opened the Public Hearing.

There were no public comments.

#### **Other Business**

#### 22-0327 Adoption of the FY 2022-23 Budget Ordinance

Dr. Kimberly Sowell, County Manager thanked the Board for their commitment and Keith Lane, Budget Director and the Budget Department staff for their assistance with the budget.

Vice Chair Jacobs read the following statement:

"Tonight our board has approved a \$750,638, 591 budget. This is the largest in Durham County history. I am proud to support this budget. It is said that a budget is a moral document. I believe that the investments made in this project reflect the priorities of this board and our community - they are investments in our children, the people of our community and our staff- the precious human capital of Durham and Durham County Government.

I want to thank County Manager Kim Sowell who has hit the ground running. She began her leadership role of Durham County Government in March, right in the middle of the budget process. Dr. Sowell recommended a budget to our board which reflected important BOCC, County and community priorities. I also want to thank our residents for all of your input into the budget process and to my fellow board members as well. Our deliberations have resulted in a final budget that makes strong community and county investments but also recognizes the economic toll of the pandemic and current inflation. This budget does not include any property tax increase. This budget also expands the potential reach and benefit of the LIHR Low Income Homeowner Relief tax grant program.

This budget does include historic investments in Durham County staff recommended by Manager Sowell- more than \$11.8 million in additional funding for cost-of-living adjustments, increased merit-pay and salary increases for critical front-line workers - detention officers, sheriff deputies and EMS first responders and others.

This budget also includes new positions throughout Durham County Government that will improve the services and programs provided to our residents such as a bilingual youth coordinator in Cooperative Extension and an Energy Project Manager to implement our Renewable Energy Plan. This budget prioritizes community engagement with the County Manager's vision of a DCo on the Go Outreach Van.

This budget is also a reflection of the policies prioritized by our Board and the values of the Durham community- investing in the education of our children and support for Durham Public Schools. With more than \$177, 151, 617 in funding for DPS for current operations and capital expenses, this budget reflects increased funding of nearly \$11 m above last year's allocation which can be used to cover the \$9.3 m requested for increases in staff salaries, benefits and teacher supplements.

This budget also reflects this Board's commitment to education and our children by increasing our annual funding of Durham Technical Community College to a total of \$12 m. This includes nearly \$1.9 m for the Durham College Promise scholarships for Durham high school graduates and the Gateway to College Program as well as \$500,000 for the BULL's (Building Up Local Labor) and Back to Work Initiative, which help Durham residents attain the good paying jobs we have in our region. This budget invests in the well-being of our children and families with an additional \$265,000 For maternal health, \$6.4 m for Durham PreK, \$265,000 for more school nurses, \$275,000 for increased Foster Care support, \$146,000 for the Community Schools program and an additional \$350,000 for implementation of our Early Childhood Action Plan.

Our Board also prioritizes investments in Agricultural Economic Development by doubling the successful Ag Grant Program to \$150,000 and our Renewable Energy Plan by joining the TJCOG Solar Program. And we are taking steps to implement our new Green Fleet Program with purchases of hybrid and electric vehicles throughout the organization.

Thank you to our County Manger Kim Sowell, our Budget Director Keith Lane, Assistant Budget Director David Ades, General Manager Claudia Hager and all of the budget staff for your outstanding work in helping us adopt this historic budget for the people of Durham County."

The Board thanked County staff for preparing and assisting with the budget, budget development skills, and having the budget prepared for approval in a timely manner.

Keith Lane, Budget Director stated a copy of the adopted FY 2022-23 Budget Ordinance would be available on the website in the coming days. He added the detailed approved budget would be available in a month. Chair Howerton stated the August "In Touch with Durham County" show would also highlight the approved budget.
