Chair Howerton read the following statement regarding the Non-Discrimination Ordinance (NDO), effective as of July 1, 2022:

"As you may well be aware, the Board of Commissioners approved the Durham County Non-Discrimination Ordinance late last year.

The ordinance is now in effect as of July 1st. The goal is to provide protection and promote equal treatment for all individuals.

The ordinance prohibits discrimination in public accommodations and employment and applies only in the unincorporated areas of the County.

If you would like to report how a business or employer may have discriminated against you, the Durham County website has a link to share information with the appropriate office.

If you visit <u>www.dconcgov</u>, the link is located on the County Manager's webpage. Simply scroll down and look for the "Non-Discrimination Ordinance Complaint Process."

Once you access the title, you will see a full-page explanation of what is prohibited by the ordinance. You can also access and fill out the complaint form to report the alleged discrimination. Complaints must be filed within 180 days of the alleged act of discrimination. Once received by County staff, a review will take place to ensure the information is complete and appropriate.

The mediation process will be administered through a third-party facilitator. Please understand the process is closed, confidential and free of charge to participants.

Joanne Pierce, General Manager stated two years ago the County aligned the Bull City United, My Brother's Keeper and Project Build Programs and invested in Bull City United to expand staff from seven to 25 with funding from the City. She added the County was leasing space for Bull City United employees and needed a central location to serve as a headquarters, meeting spaces and to serve the community.

Dr. Kimberly Sowell, County Manager stated the new location would allow for more programs and training to maximize opportunities for the community; adding this location would also be able to provide additional space for community partners as well.

The Board stated the property was located in the middle of the Hayti community and the County was purchasing the property to keep the community together and locally owned. The Board added Durham County desired to be accessible in the community and the property purchase was strategic to serve residents.

She added the property manager asked the County about purchasing the entire shopping center. Ms. Mitchell mentioned 16 of the units in the shopping center were leased and no decisions were made on those leased units.

Derek Bowens, Board of Elections Director stated the Board of Elections was split between the downtown main office and a warehouse on South Alston Avenue. He added the purchase of the property would allow for consolidation of the department at one location and provide additional space for expansion.

The Board thanked Ms. Mitchell and Mr. Bowens for their research and assistance with the purchase of the property which would better serve the Durham community.
