- **5.** Child Tax Credit Deadline for Easy Claims is Nov. 15 The deadline of November 15, 2022 is fast approaching for simplified filing for the 2021 expanded Child Tax Credit (CTC). The portal at <u>https://www.getctc.org</u> allows families to easily claim the tax credit. Simplified filing makes it easy for families with no or low incomes to claim the 2021 CTC and potentially other money. Individuals can continue to claim the 2021 expanded CTC until April 2025, but after www.GetCTC.org closes on November 15th, they will need to file full tax returns to do so.
- 6. Website Now Live for Student Loan-Forgiveness The U.S. Department of Education is now accepting applications for student loan relief beginning now through Dec. 31, 2023. This loan relief can erase up to \$20,000 for Pell Grant recipients and up to \$10,000 for non-Pell Grant recipients. - 7. Volunteer for New Cultural Roadmap Planning Group Durham County and the City of Durham have entered into a joint agreement to govern the development of the new Durham Cultural Roadmap. This roadmap is an updated strategic vision to guide and support the Bull City's local arts and cultural ecosystem and the artists and creatives that make it vibrant. Led by the Durham Cultural Advisory Board (DCAB), development of the Cultural Roadmap will include input from a Cultural Roadmap Planning Group comprised of volunteers who reflect the diversity of Durham, including young people and members of the cultural and business communities. ## **Ceremonial Items**

22-0600 Proclamation – PEACH Lead and Healthy Homes Economic Initiative and Lead Poisoning Prevention Week

Commissioner Burns read the following proclamation:

## PEACH LEAD AND HEALTHY HOMES ECONOMIC DEVELOPMENT INITIATIVE AND LEAD POISONING PREVENTION WEEK | 2022

- **WHEREAS,** in 1998, Partnership Effort for the Advancement of Children's Health (PEACH) was established with the support of Congressman David Price and EPA funding to North Carolina Central University to establish a Community University Partnership (CUP) with the Northeast Central Durham Community Reinvestment Board to explore the lingering effects of lead-based paint in older housing in the NECD community, and
- WHEREAS, in 2007 under the leadership of community-members Marion Lamberth, Lenora S. Smith, the late Effie Steele, and NCCU Public Health Education Department Chair, Dr. Theodore Parrish, submitted application and received designation as a 501 C3 IRS Charitable organization to empower grassroots communities to mitigate home hazards, including lead, mold, pesticides, indoor air quality and home safety; and

- WHEREAS, in 2009, the State of North Carolina enacted the Lead-Based Paint Hazard Management Program for Renovation, Repair and Painting, requiring that, prior to performing renovation, repair, and painting activities for compensation, companies and individuals must become certified by the NC Department of Health and Human Services, Division of Public Health, Health Hazards Control Unit; and
- **WHEREAS,** in 2014 PEACH became an authorized North Carolina and EPA training provider for the Renovate, Repair, and Painting (RRP) training program, after serving four years as a training provider with the National Center for Healthy Housing; and
- **WHEREAS,** in 2016 PEACH partnered with the Mayor's Poverty Reduction Initiative to create a Durham RRP brochure for contractors and to initiate a PEACH lead risk assessment capacity building and Healthy Homes project to educate families and to protect children from lead exposure, asthma triggers, and physical home safety hazards; and
- WHEREAS, in 2017, as a result of lead repairs by a contractor, in violation of the RRP Lead-safe rule, and that caused lead-based paint and lead-dust contamination to two neighboring properties, and where regulatory guidelines prevented contractor accountability, PEACH began a series of Town Hall meetings that culminated with the situational assessment, Identification of Regulatory Gaps in Lead Poisoning Prevention and Lead Hazards in Housing in Durham, NC that offered immediate, short term, and long term recommendations and was presented to the joint City and County Board of Elected Officials in May 2019 with the support of the Durham County Health Director; and
- WHEREAS, in 2019, to further the situational assessment recommendations, PEACH encouraged, and the City of Durham Community Development Department submitted a National League of Cities Healthy Housing Leaders Forum application and was one of six cities selected to receive technical assistance to advance effective healthy housing policies, programs and practices that protect residents from the hazards posed by asthma and lead and along with other community stakeholders completed the DURHAM Healthy Housing City Action Roadmap; and
- **WHEREAS,** in 2020, during the COVID-19 pandemic, PEACH contracted with Curamericas Global to increase COVID-19 awareness and coordinated and participated in activities that tested vulnerable community members, recruited and vaccinated hard-to-reach community members, and where hired staff became community-health workers; and
- **WHEREAS,** with the cooperation of agencies within the State of North Carolina, including Children's Environmental Health, the State Laboratory of Public Health, and the NC Lead and Healthy Homes Outreach Task Force, PEACH will continue to train contractors in lead safe work practices and to provide academic and community internships, and to provide income opportunities for low-wealth community workers, all in an effort to assist with primary prevention of lead poisoning to the 8,300 high risk children in Durham County and to help improve healthy homes for all of Durham's residents.

**NOW, THEREFORE, BE IT RESOLVED** I, Brenda Howerton, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby proclaim October 23 – 29, 2022 as

# 22-0615 Durham County Family-Friendly Workplace Policies

Tina Sherman, Senior Campaign Director, Maternal Justice at Moms Rising shared a presentation titled the *Expanding Family-Friendly Workplace Policies for Durham County Workers* which highlighted the following: Who is Moms Rising, Family-Friendly Workplace Policies, Opportunities for Expansion, Expansion to Paid Family and Medical Leave: A Matter of Equity, Use of Sick Day as Safe Days, Pregnancy Accommodations, Employment of Pregnant Workers, The Importance of Workplace Pregnancy Accommodations, Infant Mortality in North Carolina, Why are Local and State Protections Providing Pregnancy Accommodation Needs, Employer Impact and Support, Support for Lactation and Related Benefits.

Kathy Everett-Perry, Chief Employment Counsel stated Dr. Kimberly Sowell, County Manager introduced the Family-Friendly Policies during her Budget Presentation and the only new policies they wished to include was the Pregnancy Accommodations and the Wellness/Safe Days policies.

The Board stated the Pregnancy Accommodations were beneficial and vital to employees. They inquired about language and financial costs associated with the policies and asked would those topics be bought back for discussion. Ms. Sherman responded yes if the Board approved the adoption of the policies. The Board asked if specific language was needed to explain policies and their usage. Ms. Sherman replied allowing some flexibility was important and making sure employees were informed of their rights and given examples of policies was also important. She added she would assist the Human Resources Department with the development of the language for the policies.

Commissioner Burns moved, seconded by Commissioner Allam to give permission to move forward with the proposed policy changes and come back with the financial cost associated with the policies.

The motion carried unanimously.

## 22-0642 Durham County Public Health Focused Update on the COVID-19 Crisis

Mr. Jenkins shared the *COVID-19/Monkeypox/Flu Updates* which highlighted the following: Current COVID-19 Statistics, Current Race and Ethnicity Trends, COVID-19 Percent Positive Labs, Usage and Capacity Hospitalization Data, COVID-19 Community Level, Free COVID-19 Testing, Free COVID-10 At-Home Tests, COVID Vaccine Updates, Vaccine Recommendations, Monkeypox Background, Monkeypox Vaccinations and Flu Vaccine Recommendations.

The Board asked if Durham County tested two wastewater sites for COVID-19. Mr. Jenkins responded yes, adding the County received reports once a week and the report results of COVID-19 were reduced. He added the County asked the State to fund testing at an additional wastewater site in Durham County.

The Board thanked Mr. Jenkins and the Department of Health for keeping Durham County safe and educated on health needs.
