#### Law Enforcement

### **Courts & Civil Division**

<u>Civil process</u> is one of the oldest documented responsibilities of the County Sheriff. The Civil Division handles all prejudgment as well as post-judgment service of civil process papers. Deputies serve civil documents, facilitate final eviction notices, fulfill civil executions by seizing money or property, and collect back taxes owed to Durham County.

The Durham County Sheriff's Office is responsible for the safety of the public and employees that utilize the court facilities. Deputies assigned to <u>court and building security</u> are responsible for: maintaining order in the courtrooms, arranging the transfer of inmates, maintaining custody and control of inmates appearing in court, and conducting safety checks. Additionally, court deputies are responsible for placing defendants in custody immediately after a conviction to ensure they are secured and transferred to the detention facility.



# Durham County Sheriff's Office Frequently Asked Questions



### Q: How do I contact someone in the detention facility


A: There are several ways to contact loved one in the detention facility.

- 1. By Mail: Personal Mail in processed offsite and scanned to prevent contraband from entering the facility. Once the mail is processed residents view their mail on tablets.
- 2. By Phone: Detainees can call out through the contracted service provider using payphones or tablets.
- 3. Visitation: All visitation is done by video. You can video chat from your phone of computer by downloading the app.





# Durham County Sheriff's Office Frequently Asked Questions



## Q: What's the difference between the Sheriff's Office and the Police Department?

A: Durham the city covers about one-third of the county's landmass but contains about 85% of the total population. Similarly, much of what the Sheriff's Office does occurs inside the city limits and includes things like civil process, courts, animal services, and detention services. Both are full-service law enforcement agencies who respond to and investigate crimes, with the Sheriff's Office responding in the unincorporated parts of the county.







# Durham County Sheriff's Office Frequently Asked Questions

#### Q: Where do I go if I need records from the Sheriff's Office?

A: The Records Division of the Durham County Sheriff's Office is responsible for the management of all agency reports to include:

- Incident Reports
- Property Reports
- Vehicle Reports
- Missing Person Reports
- Citations
- Driver's License Pickup
- Warning Tickets

The staff issues all gun permits, and manages sex offender registrations, fingerprinting, traffic stop statistics, criminal record checks *for court officials only*, and domestic violence orders.

#### **Location & Hours of Operation**

The Records Division is on the first floor of the Durham County courthouse located at 510 South Dillard Street in Durham. The staff is available Monday through Friday from 8:30 a.m. until 5 p.m.
