Kathy Everett-Perry, Assistant County Attorney, pre Carolina General Assembly approved an Ethics Law ef cities, counties, local boards of education, unifie consolidated City/Counties to adopt a code of ethic members of those governing boards to receive educat government officials. The law specifies that "the resolution or policy containing acode of ethics, a sequired by G.S.160A-83." sented this item. She stated that the North fective August 2009 that required all districts, and governments, Sanitary districts, and some of the governing board and to require the board of commissioners shall adopt a resolution or policy containing acode of ethics, a sequired by G.S.160A-83."
