The Congestion Relief/Intermodal Transport Fund (HB148) contains the Local Government Public Transportation Sales Tax Act that allows for a ½ percent sales tax increase to fund public transportation. The tax must be approved in a referendum scheduled by the Board of County Commissioners. In order to levy the tax, a plan that provides for the allocation of the proceeds must be developed. County and MPO staff will present the status of this plan titled "The Durham County Element of the Regional Transit Plan", describe the interconnectedness of this plan with the Alternatives Analysis passenger rail project currently being conducted by the Triangle Transit Authority, and identify upcoming milestones for each of these projects.
