#### **Announcements**

Chairman Page made the following announcements:

- "In Touch with Durham County," the Durham County Television show, airs on Cable TV Channel 8 at 8:30 a.m. and 12 noon daily, 4:00 p.m. on Mondays, and 6:30 p.m. Tuesday Sundays. Our County Commissioners' meetings are also rebroadcast on Thursdays at 2:00 p.m., Saturdays at 9:00 p.m., and Sundays at 9:00 p.m.

- The FY 2013-2014 Nonprofit Agency Funding process began on November 2, 2012 with the opening of the pre-application submission period. Durham community nonprofits interested in applying for FY2014 nonprofit funding must first submit a Pre-Application Questionnaire no later than midnight on December 13, 2012. This initial assessment would be used to determine which potential applicants meet the eligibility criteria outlined in the County's nonprofit policy. Those agencies meeting the eligibility criteria would then be invited to apply for FY2014 funding. The Pre-Application Questionnaire and the Nonprofit Agency Funding Program policy would be available on the County's website from November 2 through December 13. - Durham County will also hold two general meetings to receive residents' feedback on other needs in northern Durham County. - Senior PharmAssist is Durham County's site for the state Seniors' Health Insurance Information Program (SHIIP) and would help any Medicare beneficiary in Durham evaluate his/her options for drug and health coverage. Medicare's annual election period (AEP) would be ongoing through December 7. For the last three years, two-thirds of the people seen at Senior PharmAssist during the AEP needed to switch stand-alone Part D drug plans for an average savings of \$500-\$600. #### **Minutes**

Commissioner Howerton moved, seconded by Vice-Chairman Reckhow, to approve the November 12, 2012 Regular Session Minutes of the Board.

The motion carried unanimously.

#### Recognition of Outgoing County Commissioners Philip R. Cousin, Jr. and Pam Karriker

Each Board member extended personal reflections and good wishes to Commissioners Philip R. Cousin, Jr. and Pam H. Karriker as they prepared to leave the Board. Commissioner Karriker joined the Board in September 2011, and Commissioner Cousin joined the Board in July 2012.

Commissioners Karriker and Cousin briefly remarked on their experiences serving on the Board and thanked their fellow colleagues, County staff, and citizens for being given the opportunity to serve Durham County.

The Board presented plaques to Commissioners Cousin and Karriker to commend them for their outstanding service to the citizens of Durham County.

#### **Recognition—Michael Becketts**

Mike Ruffin, County Manager, requested that Michael Becketts, Department of Social Services Director, be recognized for his efforts in helping tenants who were facing eviction from the Lincoln Apartments community. County Manager Ruffin explained that approximately 80 residents of the community received notices from their landlord that they were being evicted from their homes by the end of October. Some residents of the low income community had been

in their apartments for nearly 30 years and were unable to find new accommodations within the required timeframe. Neighbors appealed to the County and the City for help. Mr. Becketts quickly offered the assistance of his department during what he termed a "crisis." He marshaled forces and held a "resource day" for the Lincoln tenants' within their community. Social Services met with nearly 59 families and provided a range of options and services that were needed by many of the tenants facing eviction.

County Manager Ruffin thanked Mr. Becketts for being a compassionate leader and the Department of Social Services for their service.

Vice-Chairman Reckhow spoke to Mr. Becketts' swift response to the crisis and praised his "resource day" approach.

Commissioner Karriker echoed Vice-Chairman Reckhow's comments.

Commissioner Howerton noted Mr. Becketts' compassion and commended him for continuously communicating with the Board on the status of the Lincoln Apartments situation.

Mr. Becketts recognized staff members for their roles in addressing the crisis and thanked the Board for the recognition.

Commissioner Cousin stated that Mr. Becketts' compassion raised the level of his services.

Chairman Page presented the Anchor Award to Mr. Becketts.

Chairman Page offered words of praise for Mr. Becketts' actions and leadership.

County Manager Ruffin mentioned that the Anchor Award is normally accompanied by a \$200 check; however, Mr. Becketts rejected the check.

### Award Recognizing Durham County for "Employment of Persons with Disabilities

Durham County was nominated to receive the City of Durham's Mayor's Committee for Persons with Disabilities, "Disability Employment Awareness Month Award" for employment of persons with disabilities. A recognition program was held on Thursday evening, October 25, at Durham City Council Chambers. Jerelene Fullwood Carver, Director of Counseling and Disability Services at Shaw University, served as the event's keynote speaker. Assistant County Manager Deborah Craig-Ray attended the program to receive the honor on behalf of Durham County Government.

Ms. Craig-Ray introduced Donna Rosser, Durham County Health Education Specialist and a member of the Mayor's Committee for Persons with Disabilities, who nominated Durham County.

Ms. Rosser read from her nomination letter.

Chairman Page thanked Ms. Rosser for her nomination and representation on the Mayor's Committee for Persons with Disabilities.

# Resolution Authorizing the Levy of a One-Half Percent (1/2%) County Sales and Use Tax for Public Transportation

County Manager Mike Ruffin introduced this item to the Board. He reported that the North Carolina General Assembly enacted the "Local Government Public Transportation Sales Tax Act" Article 43 of Chapter 105 of the North Carolina General Statutes (Session Law 2009-527, the "Act"), which authorizes transportation authorities to levy a local sales and use tax for the purpose of financing local public transportation systems. On June 27, 2011, the Board authorized Research Triangle Regional Public Transportation Authority dba Triangle Transit to place an advisory referendum on the question of whether to levy the local sales and use tax to be placed on the November 8, 2011 ballot. A majority of those voting in the referendum voted in favor of the levy of the tax.

County Manager Ruffin highlighted the proposed resolution's request for Triangle Transit to levy the one-half percent sales and use tax pursuant to the Act. He noted that the tax does not apply to food, as exempted by N.C.G.S. § 105-506.2. The proceeds of said tax may only be used for the benefit of the Special District, created by Triangle Transit, and may only be expended in accordance with the adopted financial plan entitled, the "Durham County Bus and Rail Investment Plan" for financing, constructing, operating, and maintaining public transportation systems. If the tax is levied by TTA prior to January 1, then the collection of the tax would begin on April 1, 2013.

Chairman Page called signed speakers forward for comments.

The following speakers spoke in support of the resolution: Gerry Cohen, 8909 Taymouth Court, Raleigh 27613 Mike Shiflett, 206 W. Club Blvd., Durham 27704

Vice-Chairman Reckhow thanked Mr. Cohen for his work with drafting the transit bill and getting it passed through the General Assembly. She also thanked him for his service on the Orange County Referendum.

Vice-Chairman Reckhow thanked Mr. Shiflett for standing as leader of the Durham-Orange Transit citizen group and for hours of volunteering to get the referendum passed.

Vice-Chairman Reckhow informed the public of improvements to transit in the future as a result of the one-half percent sales tax.

Commissioner Howerton invited David King, CEO and General Manager of Triangle Transit, forward for remarks.

Commissioner Cousin pointed out that he served as Commissioner when this item was first proposed; he expressed delight to serve as Commissioner to see the proposal passed.

Commissioner Cousin moved, seconded by Vice-Chairman Reckhow, to adopt the Resolution Authorizing the Levy of a One-Half Percent (1/2%) County Sales and Use Tax for Public

Transportation pursuant to Article 43 of Chapter 105 of the North Carolina General Statutes.

The motion carried unanimously.

Chairman Page thanked Mr. King and Wib Gulley, General Counsel for Triangle Transit, for their efforts.

## RESOLUTION AUTHORIZING THE LEVY OF A ONE-HALF PERCENT (1/2%) COUNTY SALES AND USE TAX FOR PUBLIC TRANSPORTATION

WHEREAS, Article 43 of Chapter 105 of the North Carolina General Statutes (Session Law 2009-527), entitled "Local Government Public Transportation Sales Tax Act" enacted by the North Carolina General Assembly, authorizes counties and transportation authorities to levy a local sales and use tax for the purpose of financing local public transportation systems; and

WHEREAS, pursuant to N.C.G.S. § 105-509(a), on June 22, 2011, the regional public transportation authority (hereinafter, the "Authority") created a Special District consisting of the entire area of Durham County (hereinafter the "Special District"); and

WHEREAS, pursuant to N.C.G.S. § 105-510, the Durham County Board of Commissioners authorized, by Resolution dated June 27, 2011, an advisory referendum on the question of whether to levy a local sales and use tax in the County; and

WHEREAS, the referendum was held on November 8, 2011, in accordance with the procedures set forth in N.G.G.S. 163-287, at which a majority of those voting in the referendum voted for the levy of the tax, and such results were certified by the Board of Elections; and

WHEREAS, the Board of County Commissioners wish to authorize the Authority to levy said sales and use tax, effective April 1, 2013.

NOW, THEREFORE, THE BOARD OF COMMISSIONERS FOR THE COUNTY OF DURHAM DOTH RESOLVE:

- 1. The Board of Commissioners hereby authorizes the Authority to levy within the Special District one-half percent (½%) local sales and use taxes authorized by Section 2(b) of Session Law 2009-527, and codified as Part 4 of Article 43 of Chapter 105 of the General Statutes of North Carolina.
- 2. Except as provided in Part 4 of Article 46 of Chapter 105, the adoption, levy, collection, administration, and repeal of the local sales and use tax shall be in accordance with Article 39 of Chapter 105 of the General Statutes of North Carolina. This tax does not apply to food, as exempted by N.C.G.S. § 105-506.2.
- 3. Collection of the tax by the North Carolina Secretary of Revenue, and liability therefore, shall begin and continue on and after the first day of April, 2013.

- 4. The net proceeds of the tax levied herein shall be distributed by the Secretary of Revenue to the Special District and shall be expended by the Special District only for financing, constructing, operating, and maintaining public transportation systems in accordance with a finance plan entitled the 'Durham County Bus and Rail Investment Plan' adopted by the Board of County Commissioners pursuant to G.S. 105-508.1. The Special District shall use the net proceeds to supplement and not to supplant or replace existing funds or other resources for public transportation systems.
- 5. This Resolution is effective upon its adoption, and a certified copy hereof shall be forwarded to board of trustees for the Authority.

Adopted, this the 26<sup>th</sup> day of November, 2012.

Chairman Page stated that the Board also met in closed session to consider the qualifications, competence, performance, character, fitness, conditions of appointment, or conditions of initial employment of an individual public officer or employee or prospective public officer or employee, pursuant to G.S. § 143-318.11(a)(6).

Chairman Page congratulated County Manager Mike Ruffin for his stellar performance within the past year in leading the County and maintaining sound fiscal stability and for his leadership of the Strategic Plan initiative and of Durham County employees.

Vice-Chairman Reckhow thanked County Manager for an excellence performance.

Vice-Chairman Reckhow moved, seconded by Commissioner Karriker, to approve a 4.25% salary increase for the County Manager.

The motion carried unanimously.

County Manager Ruffin extended thanks to the Board and expressed joy in serving the citizens of Durham County.

## **Adjournment**

There being no further business, Chairman Page adjourned the meeting at 8:10 p.m.
