Agenda Adjustment

Chairman Reckhow announced that a reappointment to the Lincoln Community Health Center Board would be added to the end of the agenda.

2006 Outstanding Register of Deeds—Mr. Willie L. Covington

Chairman Reckhow introduced this item, stating that the North Carolina Association of Registers of Deeds recently held its annual conference in Fayetteville. At that time, Durham County Register of Deeds Willie L. Covington was recognized with two honors—the Eunice Ayers Award and the 2006 Outstanding Registers of Deeds Award. Both honors are awarded to the Register who receives a majority of votes from the 100 NC Registers who are members of the Association. (Mr. Covington has served this past year as the organization's President.)

Chairman Reckhow congratulated Mr. Covington for his outstanding service over the past year and for receiving these two prestigious honors from his peers.

Mr. Covington, Register of Deeds, thanked the Board for acknowledging his accomplishments. He recognized and thanked Register of Deeds' staff.

Proclamation Honoring "Day of Concern about Young People and Gun Violence"

Commissioner Page thanked staff for preparing the proclamation in a timely manner. He read the proclamation into the record:

PROCLAMATION

WHEREAS, Durham County recognizes our young people as our most important resource; and

WHEREAS, Durham County acknowledges that we, as a society, have a vested interest in helping children live free from fear and violence; and

WHEREAS, America's youth can help chart a new and less violent direction for the entire country by taking individual responsibility for their own decisions and actions; and

WHEREAS, American school children will be invited to take part in a national observance involving millions of their fellow students and will thereby be empowered to see themselves as significant agents of positive social change; and

WHEREAS, Durham's local observance, coordinated by the Durham Police Department's Project Safe Neighborhoods program, will give students the opportunity to make a solemn decision about their future by voluntarily signing a pledge promising that they will never take a gun to school, will never use a gun to resolve a personal problem or dispute, and will use their influence to keep friends from using a gun to settle disputes:

NOW, THEREFORE, BE IT RESOLVED that I, Ellen W. Reckhow, Chairman of the Durham County Board of Commissioners, do hereby proclaim October 18, 2006 as

"DAY OF CONCERN ABOUT YOUNG PEOPLE AND GUN VIOLENCE"

in Durham County. I encourage all citizens to join together and support the efforts to end violence among our country's youth.

Rob Faggart, Project Safe Neighborhood, made brief remarks regarding gun violence.

<u>Public Hearing—Unified Development Ordinance Text Change—Nonconformities</u> (TC06-07)

The Board was requested to receive public comments on the Unified Development Ordinance Text Change – Nonconformities (TC06-07) and to approve the Unified Development Ordinance Text Change – Nonconformities (TC06-07) incorporating revisions to Article 14 into the Unified Development Ordinance.

Frank Duke, AICP, City-County Planning Director, stated that the Planning Department, in concert with the City Attorney's office, has developed a language regarding the revision to the Nonconformities section of the Unified Development Ordinance (UDO) for consideration as ordinance amendments consistent with the direction of the Joint City-County Planning Committee (JCCPC) on April 5.

Mr. Duke also stated that the Durham Planning Commission held a public hearing on this item on August 8, 2006 to receive public comment. The Commission passed a motion recommending approval of the item (13-0). The City Council adopted the item (7-0) on September 18, 2006.

Mr. Duke recommended that the Board approve the change.

Chairman Reckhow opened the public hearing. As no one requested to speak to this issue, Chairman Reckhow closed the public hearing and referred the matter back to the Board.

Public Hearing—Draft of the Work First Block Grant Plan for 2007-2009

Jim Polk, Chairman of the Work First Planning Committee, presented the two-year Work First plan for Durham County. He began by stating that Work First is the primary program in North Carolina for administering the Temporary Assistance for Needy Families (TANF) Program. Since Work First is administered locally in each county, North Carolina law (NCGS 108A-27) requires each county to submit a County Work First Block Grant Plan every two years.

Mr. Polk provided a brief background by commenting that local leaders were appointed from various community agencies and organizations to form the Work First Planning Committee that is responsible for the development of the Work First Block Grant Plan. On August 14, 2006, the Board of County Commissioners approved the list of members for Durham's Work First Planning Committee. On August 28, 2006, the Board of County Commissioners voted to have Durham remain as a standard county.

Mr. Polk remarked that the Committee is submitting this draft to the Commissioners for review and comment and is prepared for discussion. The plan was distributed to the public from October 4-9. Mr. Polk informed the Commissioners that the final draft plan would be presented for approval at their October 23 Regular Session and must be submitted to the Department of Health and Human Services by October 31, 2006.

Vice-Chairman Heron expressed delight in reading the information provided by the Work First Planning Committee.

Chairman Reckhow concurred with Vice-Chairman Heron's comments.

In response to Chairman Reckhow's concerns regarding Work First goals, Sammy Haithcock, DSS Director, stated that in Spring 2007, the goals from the State will be available for incorporation into the Work First Plan.

Chairman Reckhow expressed concern regarding the number of children on the childcare waiting list. She asked that data be collected regarding the childcare issue for presentation to the Legislation.

Vice-Chairman Heron requested that in the future the public be given more time to review the materials prior to the public hearing.

Chairman Reckhow opened the public hearing and called signed speakers forward for comments.

<u>Victoria Peterson</u>, representing Triangle Citizens Rebuilding Communities, PO Box 101, Durham 27701, expressed concern about evaluating the organizations that have been chosen. She asked that the Board make sure that new companies entering into the area hire individuals through Work First.

Chairman Reckhow closed the public hearing and referred the matter back before the Board.

Chairman Reckhow raised an issue regarding the dropout rate in Durham County, referring to a pertinent article in <u>The Herald-Sun.</u> She stated that the article spoke about raising the compulsory attendance age. Chairman Reckhow suggested that Durham Public Schools Board of Education and the City Council partner with the Board on this matter. She also suggested that this issue be discussed at the Leadership meeting at the end of October.

Chairman Reckhow recommended that a motion be made.
