<u>Opening of Regular Session</u>—Chairman Page asked everyone to join in the Pledge of Allegiance.

Added Agenda Item - Eno River Association Presentation

Ms. Robin Jacobs, Executive Director, Eno River Association (ERA), extended holiday wishes to the Board and to the Durham community. Ms. Jacobs introduced the newly elected President of the ERA Board of Directors, Ms. Barbara Driscoll.

Ms. Driscoll thanked the Board for their continued support. She presented the Board and staff with 2014 calendars produced by the ERA. Ms. Driscoll announced that the calendars featured GPS coordinates that would link citizens with various "exotic" locations in Durham County.

Chairman Page thanked Ms. Jacobs and Ms. Driscoll for the presentation and their work with the ERA.

Minutes

Vice-Chair Howerton moved, seconded by Commissioner Reckhow, to approve as submitted the November 4, 2013 Worksession Minutes and November 11, 2013 Regular Session Minutes of the Board.

The motion carried unanimously.

<u>Honoring Durham County Librarian Lynn Richardson on Her Recent Induction into the Historical Society of NC</u>

Chairman Page introduced the item stating that the Board was requested to recognize Ms. Lynn Richardson, Durham County Library's North Carolina Collection Librarian, for her recent induction into the Historical Society of North Carolina. He stated that Ms. Richardson had been the head of Durham County Library's North Carolina Collection since 2001 and reviewed several of her accomplishments during her tenure. Chairman Page noted that the Historical Society was comprised of scholars of North Carolina history from colleges, universities, libraries and archives throughout the state and that participation was by invitation only, limited to no more than 75 active members.

Ms. Richardson thanked the Board for recognizing her induction into the Historical Society of North Carolina. She stated that the induction was even more of an honor because most of the inductees were from academic institutions and were not public librarians. Ms. Richardson commented that it had been a wonderful opportunity to serve as Durham County's local history librarian over the past 12 years. She thanked Ms. Tammy Baggett, Durham County Library Director; Mr. Mike Ruffin, County Manager; and other staff and volunteers. She stated that she looked forward to continuing to serve Durham County.

Commissioners Jacobs, Reckhow, and Howerton thanked Ms. Richardson for being such a tremendous resource for the community and congratulated her on her achievement.

Honoring 2014 Wells Fargo Principal of the Year Dr. William Logan

Chairman Page introduced the item stating that the Board was requested to recognize Dr. William Logan, Principal of Hillside High School who had been named the 2014 Wells Fargo Principal of the Year for Durham Public Schools (DPS). Chairman Page stated that the Wells Fargo Principal of the Year award was introduced in 1984 to recognize outstanding leadership in North Carolina schools and the role of the principal in establishing an environment conducive to the pursuit and achievement of academic excellence.

Chairman Page recapped Dr. Logan's career history. He noted that under Dr. Logan, the class of 2011 achieved a 100 percent graduation rate and that the school's graduation rate rose 5.5 percentage points to 83.8 percent between 2012 and 2013. Chairman Page concluded by saying that Dr. Logan would represent Region 3 (North Central) to become 2014 North Carolina Principal of the Year.

Dr. Logan thanked the Board for recognizing his award and Hillside High School. He continued saying that the school continued to make daily strides to improve student success and the school's status within the community. Dr. Logan closed by saying that that he was excited to compete at the regional and state levels to showcase the good things that were occurring in Durham Public Schools.

Vice-Chairman Howerton reflected on the announcement of Dr. Logan receiving the award. She noted the number of students who stood next to him enthusiastically the award was announced. Vice-Chairman Howerton thanked Dr. Logan for his work and for positively influencing the lives of young people.

Commissioner Jacobs congratulated Dr. Logan and thanked him for his work at Hillside High School. She stated that he had the full support of the Board at the competition finals.

Commissioner Reckhow commented that the key ingredient in school improvement was the principal as the instructional leader of the school. She stated that Dr. Logan was a role model for all other principals in the DPS system and thanked him for his excellent work.

Recognition of Durham County Engineering and Environmental Services Department, Utility Division as the Recipient of a Collection System of the Year Award

Chairman Page read the award given to staff at the competition into record.

Mr. Glen Whisler, County Engineering Director, stated that the Board was requested to recognize the Durham County Engineering and Environmental Services Department Utility Division staff for their efforts in being awarded the North Carolina American Water Works Association/Water Environment Association 2013 "Collection System of the Year" award, for systems of their size. Mr. Whisler stated that the mission of the North Carolina Collection

System of The Year Award was to identify and recognize the utility that protects the public health and the natural beauty of the environment through pro-active practices of management, operations and maintenance beyond what was required of its North Carolina Department of Environment and Natural Resources collection system permit. He continued saying that recipients of the award have demonstrated quality collections system maintenance procedures through the efficient use of labor, materials, equipment, and innovative methods to keep its collection system in good working condition to minimize health hazards and property damage that occur due to sanitary sewer overflows during both wet weather and dry weather conditions.

Mr. Whisler briefly reviewed Durham County's collection system, which included examples of the innovative collection system methods consisting of a Geographical Information System based asset management system and a comprehensive analysis of all manhole top elevations and their respective flood elevations. Mr. Whisler added that during the 2013 fiscal year, the collection system had zero reportable sanitary sewer overflows. Mr. Whisler introduced several Utility Division staff members: Alvis Richardson, Operations and Maintenance Technician II; Paul Langfield, Maintenance and Collections System Manager; Shawn Davis, Operations Manager; Ted Cradle, Project Manager and Joe Pierce, Utility Division Manager.

County Manager Ruffin commented on how the Engineering and Environmental Services Department had vastly improved the wastewater treatment facility and various processes. He thanked staff for their dedication and hard work.

Items Pulled From Consent Agenda

Consent Agenda Item No. p

p. Approve Budget Amendment 14BCC000031 appropriating \$1,000 of Wal-Mart Foundation grant funds to support the Project Lifesaver program

Commissioner Foster stated that he pulled agenda item 8p because Wal-Mart did not provide its employees with a living wage. However, he maintained that he was in full support of the Project Lifesaver program.

Commissioner Reckhow stated that she pulled agenda item 8p in order to highlight the program because it was commendable and that it would be helpful for a Sheriff's Office staff member to enlighten citizens about the availability of the program who may be in need of assistance.

Mr. Paul Sherwin, Sheriff's Office Public Information Officer, stated that the Project Lifesaver program was fairly new and had three participants enrolled. He stated that the program is intended to assist caregivers locate individuals who wander from their residences due to cognitive impairments. Mr. Sherwin continued saying that the program would be provided free to Durham County residents and that caregivers must provide proof that the individual had a cognitive impairment that predisposes them to wandering.

Chairman Page asked where the Sheriff's Office receives the remainder of its funding for the program. Mr. Sherwin responded that the initial investment in the program of \$4,000 was paid by the Durham Autism Society and was used to purchase the tracking transmitters that the individuals wear in order to be located. He continued saying that the \$1,000 grant from Wal-Mart would allow the Sheriff's Office to purchase two additional transmitters.

Commissioner Jacobs asked if information about the program would be available on the Sheriff's Department website. Mr. Sherwin stated the information was currently available on the website.

Commissioner Reckhow moved, seconded by Commissioner Jacobs, to approve Budget Amendment 14BCC000031 appropriating \$1,000 of Wal-Mart Foundation grant funds to support the Project Lifesaver program.

q. Approve Budget Ordinance Amendment 14BCC000032 to approve an increase in the FY14 distribution to Bahama Volunteer Fire Department from the Bahama Fire Tax Special Revenue Fund by \$50,859, with the funding source being an appropriation of fund balance

Commissioner Foster stated that he pulled agenda item 8q due to the funds that were requested for the repair of a Fire Department brush fire truck. He cited concern that the 2004 model year vehicle was past its current life expectancy, and therefore a \$50,000 investment to replace the chassis was not financially feasible. Commissioner Foster stated that the County should invest in a brand new brush fire truck to replace the one in question.

County Manager Ruffin stated that he had been in contact with Chief Len Needam, Bahama Volunteer Fire Department. Mr. Ruffin explained that the vehicle in question was being remounted by having an existing vehicle body placed on a new chassis and engine. He continued saying that the manufacturer's representative recommended that the vehicle be remounted in lieu of being replaced. County Manager Ruffin stated that Chief Needam advised the County that the price may increase if the agenda item were delayed.

Commissioner Jacobs stated that she would defer to the recommendation of staff.

Chairman Page questioned the life expectancy of the vehicle once the remount was completed. Mr. Mark Schell, Acting Fire Marshall, stated that the life of the body is 20 to 25 years and the life of the chassis is 9 to 12 years depending on vehicle usage. He explained that the mechanical standard was that during the life of one vehicle body, the chassis could be changed twice. Chairman Page asked what the cost would be to purchase a new brush fire truck. Mr. Schell stated that the cost would be approximately \$100,000. He concluded by saying that the cost of \$50,000 to remount the vehicle included purchasing the new chassis, moving the body to the new chassis and upgrading all of the safety equipment.

Referring to the fire study report, Commissioner Reckhow stated that the 20-year time for these types of vehicles was referenced. She continued to say that the report identified several other older vehicles within the Bahama Volunteer Fire Department and other fire departments that needed to be replaced. Commissioner Reckhow suggested that the County develop a unified capital improvement plan to address this issue.

Commissioner Jacobs moved, seconded by Commissioner Reckhow, to approve Budget Ordinance Amendment 14BCC000032 to approve an increase in the FY14 distribution to Bahama Volunteer Fire Department from the Bahama Fire Tax Special Revenue Fund by \$50,859, with the funding source being an appropriation of fund balance
